Sir,

In Producing herewith one arrested accused person namely Kalu Dey @ Sanjay (36) S/O Rabi Dey of Srma Sarani, Haiderpara, W/no-39 PS-Bhaktinagar Dist-Jalpaiguri arrested him u/s 41 Cr.P.C along with the seized articles viz

1. One (01) improvised single shooter fire arms iron made having length about 22 cm with body, trigger, firing pin, barrel and fiber fitted butt having marked with "Mica Strial", packed labeled & sealed as Exhibit -A
2. 03 (Three) pcs live Ammunition having marked "8 MM K.F" at the base of each cartridge, packed, labeled & sealed as Exhibit -B
3. One Hero Maestro scooty white colour having registration no- WB 74 AL 0342, seized under proper seizure list duly signed by the witnesses.

I, SI Sajal Roy of Bhaktinagar Police Station, Siliguri Police Commissionerate do hereby submit this written complaint against the above noted accused person to the effect that, on 05.04.2021 at 18.15 hrs, I received a specific reliable source information that, one person will come with one arms by two wheeler at infront of Market complex, Pranami Mandir Road, Bhaktinagar for sale it to one person for his wrongful gain. This refers to Bhaktinagar PS GDE no- 284 dated 05.04.21. I informed to I/C Bhaktinagar, PS about the information. At 18.25 hrs as per his kind direction myself along with ASI Rabin Lama, ASI Biswajit Saha, C/ 374 Debraj Biswas, and CVF/619 Dharmendra Roy, CVF/614 Sumit Kr Roy, CVF/233 Amit Mallick all of Bhaktinagar Police Station, Siliguri Police Commissionerate left for Market complex, Pranami Mandir Road, Bhaktinagar to verify the veracity of the information which refers to GDE No. 285 Dt. 05.04.21. At about 18.45 hrs we reached at infront of Market complex, Pranami Mandir Road, Bhaktinagar and meanwhile called two independent witnesses namely; (1) Dipak Biswas (35) S/O Lt. Gopal Biswas of Jaleswari Bazar, Sarada mor PS-Bhaktinagar Dist- Jalpaiguri and (2) Md Mashir (32) S/O Md Taslim of Limbu Busty, Prakash Nagar, Near Purusattam Building PS-Bhaktinagar Dist-Jalpaiguri and disclosed our identity and informed them about the information and requested them to accompany us in the whole process during search and seizure, if any. Being accompanied by source and the witnesses our whole police party started keeping watch over people in and around Market complex, Pranami Mandir Road, Bhaktinagar and also the passengers of different vehicle. At around 20.25 hrs amidst many people one suspect person was seen while riding one scooty and the source identified him. I alerted all my officers and force at the spot and apprehended the above noted person with scooty and on being asked he disclosed his name & identity as noted above.

During search I recovered one fire arms from the possession of Kalu Dey @ Sanjay which was kept his right waist & Three rounds of ammunitions in his right pocket. On being asked he failed to produced any valid license in respect of possession of such gun. On being demand he failed to justify, about his movement in a scooty carrying a Fire Arms. On further interrogation he stated that he had procured the said fire arms illegally with intend to sale under Bhaktinagar area for his wrong full gain. His movement was suspicious and he could not able to even clarify his alibi and status why he is moving in this area. Myself with the help of my team and in presence of local witness searched him but found nothing except fire Arms & ammunitions.

Accordingly I seized 1. One (01) improvised single shooter fire arms iron made having length about 22 cm with body, trigger, firing pin, barrel and fiber fitted butt having marked with "Mica Strial", packed labeled & sealed as Exhibit -A 2. 03 (Three) pcs live Ammunition having marked "8 MM K.F" at the base of each cartridge, packed, labeled & sealed as Exhibit -B 3. One Hero Maestro scooty white colour having registration no- WB 74 AL 0342 under proper



arms & ammunition separately on the spot.

The seizure & lable was made in between 20.35 Hrs to 21.55 Hrs of dated 05.04.21. Then I arrested him after observing all formalities and issued memo of arrest.

Therefore I pray before you to start a case against the above noted accused person namely Kalu Dey @ Sanjay ( 36) S/O Ram Dey of Srma Sarani ,Haiderpara ,W/no-39 PS-Bhaktinagar Dist-Jalpaiguri under proper section of law and to cause its investigation.
