In producing here with five accused persons namely 1)Sujit Sarkar(31) s/o-Lt Malin Sarkar of Netaji Para,Panchanan Road PS-Bhaktinagar Dist-Jalpaiguri 2)Babu Gurung(38) s/o-Lt Dilip Gurung of Madya Santinagar,Amtala More PS-Bhaktinagar Dist-Jalpaiguri 3)Gopal Biswas(45) s/o-Lt Swadhin Ch Biswas of Santinagar,Netaji Para,Panchanan Road PS-Bhaktinagar Dist-Jalpaiguri 4)Sankar Das(58) s/o-Lt Bhupendra Nath Das of Dangipara,W/N-06 PS-Siliguri Dist-Darjeeling 5)Ganesh Mandol(52) s/o-Lt Dinesh Mandol of Madya Santinagar PS-Bhaktinagar Dist-Jalpaiguri along with following seized articles under proper seizure list:

1. Two numbers (02) of local hand-made crude Bomb with one nylon hand bag.

I, S.I Nur Alam Siddik of Detective Department , Siliguri Police Commissinerate do hereby lodge this written complaint against five accused persons namely 1)Sujit Sarkar(31) s/o-Lt Malin Sarkar of Netaji Para,Panchanan Road PS-Bhaktinagar Dist-Jalpaiguri 2)Babu Gurung(38) s/o-Lt Dilip Gurung of Madya Santinagar,Amtala More PS-Bhaktinagar Dist-Jalpaiguri 3)Gopal Biswas(45) s/o-Lt Swadhin Ch Biswas of Santinagar,Netaji Para,Panchanan Road PS-Bhaktinagar Dist-Jalpaiguri 4)Sankar Das(58) s/o-Lt Bhupendra Nath Das of Dangipara,W/N-06 PS-Siliguri Dist-Darjeeling 5)Ganesh Mandol(52) s/o-Lt Dinesh Mandol of Madya Santinagar PS-Bhaktinagar Dist-Jalpaiguri to the effect that on 05.04.21 at received a specific input that one Sujit Sarkar and his some associates kept concealed some hand-made crude Bomb in one nylon hand bag at the house of one Sankar Das at Kankata more under Bhaktinagar PS. After received this information instant I served to my superior. As per kind direction of ACP-I,DD,SPC vide DD,SPC GDE NO-15/21 DTD 05.04.21,I along with SI RINZEE DORJEE SHERPA ,C/-1054 ARABINDA ROY, C/- 932 PABITRA DAS, C/-945 KRISHNA BARMAN left for Kantakata more at the house of Sankar Das. After reaching near spot on 06.04.21 at 00.10 hrs , we cordoned the house of Sankar Das and started enter in to the house and found that five persons were seating in a chair and seeing our police party ,they tried to flee away from the spot. We then chased them and could be able to apprehend them, on interrogation they disclosed their name and identities as noted above. Also found that the house owner Sankar Das also present that spot. Seeing their suspicious motive, we informed two local witnesses to remain present at that spot .our police team conducted search in presence of witnesses and found that two numbers of local hand -made crude Bomb in a nylon hand bag kept concealed in the corner side of the said room. Our police team recovered the two numbers of local hand -made crude Bomb .During interrogation they confessed their guilt and admitted that they kept concealed the bombs in the said room. Then I seized the above noted items from their possession in presence of witnesses duly signed by them and the accused persons .Than I arrested the accused persons after appraising their ground of arrest and observing proper formalities. After seizure, the above noted two numbers of local hand made crude Bomb are placed in a safety way and also covered with the sand bag. The seizure was made On 06.04.21 in between 00.20 hrs and 00.40 hrs.

On further interrogation, they admitted that they had procured the local hand made crude Bomb for the purpose of selling & supplying the hand made bomb to the people of Siliguri area for their personal gain.

It is also noted that the above noted seized explosive substances are likely to endanger of human life and it may causes to any serious injury. The above noted accused persons were intentionally and knowingly kept the explosive substances for their wrongful gain.

In this circumstances, I therefore pray that may kindly be started a case against the above noted accused persons namely 1) Sujit Sarkar(31) s/o-Lt Malin Sarkar of Netaji Para, Panchanan Road PS-Bhaktinagar Dist-Jalpaiguri 2) Babu Gurung(38) s/o-Lt Dilip Gurung of Madya Santinagar, Amtala More PS-Bhaktinagar Dist-Jalpaiguri 3) Gopal Biswas(45) s/o-Lt Swadhin Ch Biswas of Santinagar, Netaji Para, Panchanan Road PS-Bhaktinagar Dist-Jalpaiguri 4) Sankar Das(58) s/o-Lt Bhupendra Nath Das of Dangipara, W/N-06 PS-Siliguri Dist-Darjeeling 5) Ganesh Mandol(52) s/o-Lt Dinesh Mandol of Madya Santinagar PS-Bhaktinagar Dist-Jalpaiguri under proper section of law and arrange for its investigation.
