Sir,
In producing herewith one accused person namely Bhaskar Chetri (40) S/O Hasta Bahadur Chetri of Vivekananda nagar , near Health centre PS- Bhaktinagar Dist- Jalpaiguri along with the following seized articles as per proper seizure list:

1. Eight (08) Bottle of Himalayan Gold Country Spirit (each bottle containing 600 ML) .
2. Eight (08) Bottles of Boss Country Spirit (each bottle containing 600 ML)
3. Eleven (11) Bottle of Kingfisher Strong premium beer (each bottle containing 650 ML)
4. Two (02) Bottle of Josh Country sprit (each bottle containing 600 ML.)
5. One (01) Bottle of Royal Stage deluxe whisky containing 750 ML.

I, SI Sajal Roy of Bhaktinagar PS,SPC lodged a written complainant against the above noted person to the effect that today i.e. on 07.04.2021 hrs at 20.45 hrs received a source information that at in front of Himalayan Kanya gate iii ,PS-Bhaktinagar,Jalpaiguri some persons have gathered huge amount of liquor illegally for selling the same in the customer for their wrongful gain. This refers to Bhaktinagar PS GDE no- 458 dated 07.04.21. I informed to I/C Bhaktinagar PS about the information . As per his kind instruction I along with, ASI Rabin Lama,CVF/619 Dharmendra Roy, CVF/614 Sumit kr.Roy as proceed to at Himalayan kanya gate iii to work out the information. At 21.15 hrs we reached at the spot, sometimes after being identified by the source our police party held raid at in front of Himalayan Kanya gate iii ,PS-Bhaktinagar,Jalpaiguri and recovered the above noted articles from the possession of above noted accused person namely Bhaskar Chetri (40) S/O Hasta Bahadur Chetri of Vivekananda nagar , near Health centre PS- Bhaktinagar Dist- Jalpaiguri .On demand he could not produce any valid license/documents in support of said liquor. He become nervous and admitted his guilt before us and stated that he sell the same in the customer since long for his wrongful gain. In presence of witnesses namely 1) Suraj Biswakarma (30) S/O Bharat Biswakarma of Kamala nagar , Near Health centre W/no- 42 PS -Bhaktinagar Dist-Jalpaiguri . I seized the above noted articles from the possession of above noted accused person after preparing proper seizure list and took signature of the accused person and witnesses. The seizure was made between 21.35 hrs to 22.05 hrs. I arrested the said person u/s 41 Cr.P.C. and issued Memo of arrest appraising the ground of arrest in presence of witnesses.

I therefore request you a specific case may kindly be started against the accused person namely Bhaskar Chetri (40) S/O Hasta Bahadur Chetri of Vivekananda nagar , near Health centre PS- Bhaktinagar Dist- Jalpaiguri under proper section of law.
