Sir,

In producing herewith one arrested accused person namely Sefali Khatun (45), W/O- Lt Md Sagir Mansuri of BRI Colony, Khudiram pally, W/No-1, P.S.- Pradhan nagar, Dist- Darjeeling, along with the following seized articles under seizure as per seizure list:-

- (i) One transparent plastic pouch containing 32 Grams said to be Brown Sugar, recovered from under the bed of accused Sefali Khatun and marked as Exhibit-A, (with pouch),
- (ii) Five (05) Grams of said to be Brown Sugar taken out from Exhibit-A as a sample for examination and report Marked as Exhibit-A-1,
- (iii) One silver colour small digital weighing machine,
- (iv) One black colour Lava mobile, one black and white color Micromax mobile, one Samsung navy blue color mobile, one Apple i-pad (Model No A1893),
- (v) Cash INR Rs. 1,40,800/- (One lakh fourty thousand eight hundred only) denomination as (Rs. 500 X 169), (Rs. 200 X 64), (Rs.100 X 435) which is kept in a red colour carry bag.

I, SI Binup Mahato of Pradhannagar Police station, Siliguri Police Commissionerate do here by lodge this written complaint against Sefali Khatun (45), W/O- Lt Md Sagir Mansuri of BRI Colony, Khudiram pally, W/No-1, P.S.- Pradhan nagar, Dist- Darjeeling to the effect that today on 07.04.2021 at about 05.35 hrs. I received a specific source input that one lady is selling Brown Sugar to her designed customers at BRI Colony area for her wrongful gain. The matter was diarized vide Pradhannagar PS GDE No.468 Dt- 07.04.2021. Accordingly, I informed the matter to the Inspector in Charge, Pradhannagar Police Station in writing a letter to him and expressed the entire information. As per his kind direction myself along with ASI Binod Jha, ASI Debasish Das, ASI Ratan Pradhan, ASI Anup Sarkar, PSI Chetan Danga, PSI Youel Lepcha, PSI Kalyan Saha, LC/1263 Sujata Thapa, LC/1280 Bhakta kumara gurung LC/744 Sarda Sarki, CV-223 Sapan Cheetri, CV-131 Ranjan Sharma, CV-128 Ajay kr Sahani all of Pradhannagar PS left for BRI Colony under PS Pradhannagar by govt. vehicle having no WB 74 AA-0632 at 05.45 hrs to verify the veracity of the information vide Pradhannagar PS GDE No. 469 , Dt- 07.04.2021.

At the time of departure from office I took envelope, white paper, sealing wax, gum, seal, weight machine etc. At about 05.55 hrs we arrived at BRI Colony, and called three independent witnesses namely i) Kundal Barman (35), S/O- Hare Krishna Barman of Ujanu Durgaguri, Nabagraha mandir, P.S. Pradhan nagar, Dist- Darjeeling, ii) Bijendra Kapoor @ Masum (36), S/O- Lt Bastiram Kapoor of BRI Colony, Near RPF Barrack, W/No-1, P.S. Pradhan nagar, Dist- Darjeeling, iii) Bimla Bhagat (50), W/O- Sanjay Singh of BRI Colony, Khudirampally, P.S. Pradhan nagar, Dist- Darjeeling and disclosed our identity and informed them about the information in hand and requested them to accompany us in the whole process during search and seizure if necessary with a written letter and necessary permission of their presence and as witnesses of entire process under relevant provision of law. As identified by the source we reached in the house of Sefali Khatun (45), W/O- Lt Md Sagir Mansuri of BRI Colony, Khudiram pally, W/No-1, P.S.- Pradhan nagar, Dist- Darjeeling. At the movement of police at the house one person was seen fled away through the back side door of the home.

After disclosing our identity, we detained the above noted person with strong reason to believe that she is illegally possessing brown Sugar in her possession at her house. I then gave her option in writing whether she wanted to be searched in presence of Executive Magistrate or by any Gazetted Officer. Then she agreed to be searched by one of them. Further, I served her a notice in accordance with provisions of law in this regards. I also offered the independent witnesses and the accused person to search our Police Party as per provision. But she did not searched by lady police party. Accordingly I informed the matter to I/C Pradhannagar P.S. and requested him to come at BRI Colony, Khudiram pally to remain present and to supervise the search and seizure being the gazette officer. Accordingly at 06.50 hrs Sri Subhasish Chaki, I/C Pradhannagar P.S., SPC arrived at BRI Colony as Gazatted Officer and in presence of three independent public witnesses searched the house of detained person following all formalities keeping his decency and recovered One transparent plastic pouch containing said to be Brown Sugar from which was kept under the bed of the said accused. On demand in presence of the Gazetted Officer, Sri Subhasish Chaki, I/C Pradhan nagar P.S., SPC she failed to produce any valid document in support of possessing of the brown sugar, Cash and other articles.

I, accordingly weighted the same by the weighing instrument and found total 32 Grams of said to be brown sugar in the said packet and marked as Exhibit- A. Further, on search we found ii) One silver colour small digital weighing machine, iii) 03 Nos mobile phone & one I-pad, iv) Cash INR Rs. 1,40,800/- (One lakh fourty thousand eight hundred only) which is kept in a red colour carry bag, whereas she confessed that it was a selling money of the contraband articles i.e, Brown Sugar from lasi night. I also labeled and sealed the articles in presence of the Subhasish Chaki, I/C Pradhan nagar P.S., SPC acting as ,Gazatted Officer and independent witnesses and accused person. Then I seized the above noted articles under proper seizure list and label duly signed by the above noted witnesses and the Gazetted Officer and acknowledged by the accused person. The seizure was made between 06.55 hrs to 07.20 hrs. On further asked the apprehend person confessed that the person who fled away from her house on arrival of police party happen to be her son -in-law named Md. Akbar(24)s/o Md. Amar of Tikiapara,Ps.Siliguri, and he is the supplier of Brown Sugar to her house. She also stated that she is selling the same in high rate to the local people of the local area for her personal gain by illegal means. On interrogation she disclosed that he have been dealing in such business of selling the brown sugar illegally since a long time.

Then, I arrested the above noted accused person after observing all guidelines of Hon'ble Apex court of arrest as well as after disclosing the cause of arrest and issued necessary Memo of Arrest. Thus arrested accused person named Sefali Khatun (45), W/O- Lt Md Sagir Mansuri of BRI Colony, Khudiram pally, W/No-1, P.S.- Pradhan nagar, Dist- Darjeeling violated the terms and condition of Narcotic Drugs for possessing said to be brown sugar without any valid authority & license.

Under the above circumstances, I pray to you that a specific case under proper section of law may kindly be started against the accused person named Sefali Khatun (45), W/O- Lt Md Sagir Mansuri of BRI Colony, Khudiram pally, W/No-1, P.S.- Pradhan nagar, Dist- Darjeeling and arrange for its investigation.
