I, Pradip Das, son of Late Sachin Das, of Oodlabari, Subhaspally, P.O. Manabari, Dist. Jalpaiguri would like to bring it to your kind attention that 72-year-old mother Kalpana Das suffering from jaundice, uric acid and some other associated illness has been refused admission under Swasthya Sathi Scheme by Lifeline Hospital at Sevoke Road, Siliguri.

On 2/4/2021, I brought my mother from Mal Hospital to Lifeline Hospital (Lifeline Medical Research and Cancer Institute) at Sevoke near Bhaktinagar PS in Jalpaiguri District around 3:30 PM in serious condition with the hope that we would be able to get our mother treated under Swasthya Sathi Scheme in a better health infrastructure. On approaching the hospital, I told them that I would like to get my mother admitted under Swasthya Sathi Scheme. They flatly denied any admission under Swasthya Sathi Card and informed that they can admit my mother only with cash deposit and insisted us to make some initial deposit immediately to start her treatment. We were dead tired the whole day shifting my mother from one place to another and got puzzled as to what to do then. No option was left for us and the only concern was to get my mother admitted somehow and ultimately we had to get her admitted with whatever we had then.

Now, it has been six days since my mother is admitted and the Nursing Home has already billed around Rs. 1.5 lakh within 6 days which is impossible for us to defray. The Nursing Home is warning us to make payment and thereafter they will release the patient.

I work as a petty security guard at Oodlabari and my elder brother also works as a garage mechanic and we are unable to make any payment owing to our hard financial constraints.

I therefore request you to kindly look into the matter and kindly save us from this difficult situation.
