We got one Chq (No-036159, Amt-42000 Dt-31.3.21, Union Bank of India) against two machine. After his request we deposited the Chq on 3.4.21 in IDBI Bank of Sevoke Road. But We have informed by the bank that Chq has been bounced due to insufficient fund. After several follow-up and calling, through phone he promised us to pay the amount through NEFT on 8.4.21. But his phone is now in switched off mode. From different source we come to know that he has another rented flat at Hakimpara. We visited the flat but it is in lockdown condition as same as jyotinagar.
