my family relatives and close friend. They were visiting Sriguru,
WB for leisure purpose and was staying in my farmhouse -
Minal, Malgaria, Sriguru WB.

Today (08/04/2021) they were driving around the city in my
car WL-TV 7351 [Ex. Etico] somewhere around 10am. At
about 10.15 hrs, Mr. Rajiv identified few goons lurking around the car
at the traffic light of course more in particular, Mr. Rajiv
identified Vijay who was accompanied by 1-2 more people.
In order to maintain their safety they tried to speed up the
vehicle in order to leave the goons behind. In the process
of doing so, the vehicle suddenly stopped working on the
flyover near Venkateshwar.

Mr. Rajiv and Mr. Harshad left the car and ran towards
the Sriguru police station because Mr. Sanjay Singh is still
missing.

We all afraid to say that I fear the safety of Mr. Sanjay
Please take the necessary action as soon as possible.
