 my family relations and close friend. They were visiting Siliguri,  
 with for leisure purpose and was staying in my farmhouse -  
 Hiral, Malgara, Siliguri WB.

Today (08/04/2021) they were driving around the city in my  
 car WB-THV 7351 [in Estico]. Somewhere around venue more  
 Siliguri, Mr. Rajiv identified few goods looking around the car  
 at the traffic light of venue more. In particular, Mr. Rajiv  
 identified "Vijay" who was accompanied by 1-2 more people.

In order to maintain their safety they tried to speed up the  
 vehicle in order to leave the goods behind. In the process  
 of doing so, the vehicle suddenly stopped working on the  
 flyover near venue more.

Mr. Rajiv and Mr. Harshad left the car and ran towards  
 the Siliguri Police Station whereas Mr. Sanjay Singh is still  
 missing.

We are afraid to say that I fear the safety of Mr. Sanjay  
 Please take the necessary action as soon as possible.
