Sir,

In producing here with the accused person namely- Ashok Mahato (38) yrs. S/O-Late Parmeswar Mahato of Santoshi Nagar Main Road near Khatushyam Mandir, Ward No-5, P.S-Siliguri, Dist. Darjeeling, along with seized (15) Fifteen bottles of Himalaya Gold 60 up Country spirit containing 600 in each bottle mentioning M.R.P of Rs- 100/- in each bottle i.e. total amount of Rs-1500/- (One thousand Five Hundred) in which 01 (one) bottle taken as sample and marked as Exhibit- "A-1"

I beg to report that today i.e. On 09-04-21 while performing special raid against illegal alcohol, at 08-45 hrs. I received a source information that one Ashok Mahato (39) yrs. S/O-Late Parmeswar Mahato of Santoshinagar Main Road near Khatushyam Mandir, Ward No-5, P.S-Siliguri, Dist. Darjeeling is selling huge alcohol at Santoshinagar Main Road near Khatushyam Mandir in side house of the accused person, P.S-Siliguri, Dist. Darjeeling. Under Siliguri P.S. without any valid license and documents in higher price than the actual value for his illegal gain. Accordingly I informed the fact to I/C. Siliguri P.S over telephone who directed and instructed me to verify the veracity of the information. Accordingly, myself along with force left for at Vivekananda Road, Khalpara, in side Gupta Hotel, Siliguri, S.P.C. to verify the veracity of the information vide Khalpara TOP CDE No -591/21 Dated- 09-04-21. After reaching at Santoshinagar Main Road near Khatushyam Mandir in side house of the accused person Ashok Mahato, Santoshinagar, P.S-Siliguri, Siliguri, S.P.C., at 09:10 hrs and as shown by the source, I found the above noted person is selling liquor and selling secretly at Vivekananda Road, in side Gupta Hotel, Siliguri, S.P.C. to different persons and seeing the Police party the above noted person try to flee away but we managed to intercept him. On being asked he disclosed his identity as mentioned above. During search, I could recover the above noted alcohol kept in a gunny bag. During interrogation he admitted that he is selling alcohol for his wrongful gain. On demand he failed to produce any valid license or documents in support of such business. During local inquiry it has been confirmed that the above noted person is selling alcohol illegally since long. Accordingly, I seized (15) Fifteen bottles of Himalaya Gold 60 up Country spirit containing 600 ML in each bottle mentioning M.R.P of Rs- 100/- in each bottle i.e. total amount of Rs-1500/- (One thousand Five Hundred) in which 01 (one) bottle taken as sample and marked as Exhibit- "A-1". The above noted recovered I.D. liquors under proper seizure list duly packed, sealed and labeled in presence of witnesses and took their signature in the seizure list and labels and also arrested the above noted accused person U/S- 41 Cr.P.C under proper memo of arrest and observing all the formalities of arrest. The entire search and seizure process completed in between 09:15 hrs to 09:45 hrs on 09-04-21.

-Under the circumstances one specific case may kindly be started against the arrested accused person namely- Ashok Mahato (39) yrs. S/O-Late Parmeswar Mahato of Santoshinagar Main Road near Khatushyam Mandir, Ward No-5, P.S-Siliguri, Dist. Darjeeling, for the possessing and selling alcohol illegally and arrange for its investigation.
