I, Smt. Rita Jaiswal, Wife of Sri Rajib Kumar Jaiswal, resident of Babupara, Ward No.26 of S.M.C., P.S. Siliguri, Dist. Darjeeling, West Bengal, would like to state you following facts:-

That I have a Godown at Milan Pally, Siliguri.

That Sunil Kumar Jaiswal, Son of Dr. Bhikhi Prasad Jaiswal is my brother-in-law, who is residing above my Godown at Milan Pally, Siliguri.

That today i.e. on 09.04.2021 at about 2:10 p.m. said Sunil Kumar Jaiswal some garbage has been kept in front of my said Godown, when I protest the said illegal activities of said Sunil Kumar Jaiswal and his wife of Smt. Dolly Bhagat both of them suddenly attacked me entered into my godwon and started to abuse in filthy languages and starting threatening me and my husband Sri Rajib Kumar Jaiswal, Son of Dr. Bhikhi Prasad Jaiswal and beat me and my husband by fists and blows and by kicks.

Sir, at the time of incident when my old aged father-in-law came to save us they also beat my father-in-law brutally. The above named accused are dangerous and desperate in nature. They openly threatened me and my husband that anytime they may murder me and my family members.

I, therefore, request you to kindly take necessary legal action against the aforesaid culprits for the commission of the aforesaid offence by them upon us.
