Sir,

With due respect, I Smt. Dabli Bhagat @ Jaiswal, W/o Sri Sunil Jaiswal, resident of Milanpally, SMC, Ward No.- 25, P.O. & P.S.-Siliguri, District-Darjeeling, would like to inform you that today i.e. 9-4-2021 at about 3 pm, my brother-in-law Rajiv Jaiswal S/o Bhikhi Prasad and his wife Rita Gupta @ Jaiswal, residents of Babupara, near Jyotsnamayee School, P.O. & P.S.-Siliguri, Dist-Darjeeling came at my house and without any authentic reasons, they have started abusing me and my husband in filthy languages and when I have raised my objection, the said Rajiv Jaiswal has started assaulting my husband by fist and blows by threatening that they will kill my husband and when I alongwith my old aged father-in-law tried to protect my husband, the said Rita Gupta caught hold my hairs and has started assaulting me by felling me on ground and the said Rajiv Jaiswal has mercilessly assaulted my husband causing we both have sustained serious injuries on our respective parts. Not only that were so furious that they have started throwing our household articles and have damaged the household articles worth Rs. 20,000/- when I alongwith my husband and father-in-law have raised our hue and cry to seek help for our life, they have fled away by snatching the mobile phone of my husband with threatening that if we dare to lodge any complaint against them, then we have to face serious consequences. The above named persons have trespassed in our house and assaulted us and damaged our household articles and snatched mobile phone.

After the said incident of assault and considering the injuries of my husband we had been to Siliguri Hospital and after seeing injuries, the doctors have advised my husband to admit in the hospital of treatment but due to fear of Covid 19, we have decided to continue his treatment at home.

So requesting your good office to investigate the matter and take necessary legal action against the above named persons for the interest of justice.
