Sir,

I, Sachin Agarwal, s/o Shyam Sunder Agarwal, resident of Babupara, P.S. Siliguri, District Darjeeling, would like to inform you that I along with my elder brother namely, Deepak Agarwal and my father, are running a shop of clothes under the name and style "Swagat", situated at Mahabirasthan, Siliguri. That adjacent to our shop, there is the shop named "Ankur", of Biplab Kundu son of Topuda resident of Alu Chowdhury More, Babupara, Siliguri and he is also dealing in clothes item. That from quite some time the said Biplab Kundu is creating trouble in our business and he holds a grudge against us. That today on 10/4/21 at 5 pm the said Biplab Kundu on a trifle matter of price of our clothing started unnecessary quarrelling with my elder brother namely, Deepak Agarwal outside our shop. I was sitting in my shop and the said Biplab Kundu started saying that today he will not leave anyone in our family. That his staff namely PotoI also joined him and he brought a wooden battam and gave the same to Biplab Kundu and the said Biplab Kundu hit my brother on his head with the intention to kill him, luckily my brother moved his head as a result the battam hit the shoulder of my brother as a result my brother fell down he was crying with pain, I came for his rescue and the said Biplab Kundu and PotoI also started hitting me on my back. That meanwhile my staff and local people came and rescued us from their clutches. That my cousin Sandeep Agarwal immediately took my brother to the local hospital and where the doctor said that his collar bone has broken. That if at the right moment local people would not have arrived they would have killed us.

I therefore request you to look into the matter and take necessary action against Biplab Kundu and PotoI
