
02. The above passenger approached for security check at Frisking Booth No.01, where on duty Shri Suman Kumar Biswas (HC/GD) was detailed. During frisking of said passenger, on duty HC/GD found 08 small Pkt of dark brown colour gel type items packed with plastic zip packet. On enquiry, the said pax disclosed that he has carrying of 08 Nos. of Opium Pkts purchased from some grocery shop, Siliguri (W.B).

03. The above passenger is found to be suspected in possession as well as carrying contra banned items i.e. Opium during his journey from Bagdogra to Delhi by Air India flight. The above pax has been offloaded and did not allow to board the flight due to carrying of Contra banned item svaccisecurity reason by the Air India.


