Sir,

I, Sri Sushil Roy, son of Late Tepru Singh Roy @ Tepru Das, resident of Gital Para, P.O. Sevoke Road, P.S. Bhaktinagar, District- Jalpaiguri, beg to lodge this complaint as under:

1. That it has been learnt that an Application under Section 144 of Cr.P.C with regard to the land measuring 1.98 Acre in R.S Plot No. 549, 499/993 and 540/1006 in R.S Khatian No.98/1 of Mouza- Dabgram, Police Station- Bhaktinagar, District- Jalpaiguri, was filed against Smt. Radhika Kholey @ Gholey (Gurung) and 04 (four) others, showing me as the Petitioner of the said Application, in the Court of the Ld. Sub-Divisional Magistrate (Sadar), Jalpaiguri.

That on getting knowledge of the said fact, I, on enquiry, also came to learn that 1) Sri Himel Mahato, Son of Sri Ram Mahato, 2) Sri Prabin Biswakarma, Son of Sri Shyam Biswakarma, 3) Sri Rajen Biswakarma, Son of Balabhadra Biswakarma, 4) Sri Prakash Singh, Son of Late Mohan Singh, 5) Sri Sajjan Thapa, Son of Mani Kumar Thapa and 6) Sri Satten Thapa, Son of Mani Kumar Thapa, all are residents of Shastri Nagar, P.O. Sevoke Road, P.S. Bhaktinagar, District- Jalpaiguri, had filed the said Application under Section 144 of Cr.P.C, in my name, with my forged signatures and upon the said Application, a case being Ptn/R/No.218/21 dated 19.02.2021 was started against Smt. Radhika Kholey @ Gholey (Gurung) and 04 (four) others. All the signatures in the name of Sushil Roy as appeared in the said Application are not my signatures and the said Sri Himel Mahato and 05 (five) others, for the purpose of grabbing my aforesaid land and also for the purpose of cheating me, had filed the said Application under Section 144 of Cr.P.C with my forged signatures.

You are, therefore, requested to enquiry into the above matter and take immediate steps against said Sri Himel Mahato and 05 (five) others in accordance with law.
