Sir,  
I, Sagar Ray, s/o late Nirmalendu Roy of Haiderpara Siliguri,  
Ward No. 39, hereby like to inform you that, Rama Sarkar  
(self acclaimed agent/Proprietor of Axis Bank) has threaten me  
using abusive language and threaten me to take my newly  
purchased car by force, which is currently under Axis bank  
finance. This incident took place on and from 3.00 Pm dt. 9.4.21  
from Ramkrishna Road, Siliguri.

Rama Sarkar called me by phone by 2.40Pm to meet me at  
Haiderpara. When I was going to Haiderpara walking down to my  
residence for my two wheeler, he forced me to go with him to  
Axisbank, Car loan department at Service Road.

Due to lock down period of almost 8-9 months, I missed 3EMI  
in past 16 months time from date of purchase of the car. I had  
taken time by calling Mr. Pankaj Paul, Sales executive of Axis Bank  
mobile no: 98325-45010 to deposit the due amount after 15th of  
April 2021. Though I intimated the same to Mr. Rama Sarkar, he  
denied the fact of any call from Sales department. He insisted me  
to deposit the entire amount right on the spot, and started to defame  
me with his abusive words and hoodligan nature. I started to  
feel anxious since people knows me for my good nature and behavior  
Rama Sarkar took me to Axis Bank, Service Road, Auto loan branch  
and made me wait till 40-45 minutes. In side the bank, he did not  
allowed me to talk to any one and wasted my time without any  
fruitful result. I understood his intention of harassing me  
by wasting time and his trying to broke my moral with his despotic  
attitude. Lastly after almost 50 minutes I decided to leave the  
bank premises. Outside the door, near the lift I told him for  
his wrong behaviour and to speak with dignity. Also I told him  
that the Axis Bank also do not endorse his ill behaviour and  
disrespectful nature to the customers. In response to my words  
Rama Sarkar threaten me of dire consequences, attack myself  
and we entangled in a scuffle.

After the scuffle I left the bank premises and heard  
him with some local goons reached my locality and shouted  
viciously over phone to me.

I request you to kindly look into the matter and  
safeguard me, my family and belongings from possible damage.
