Subject: First Information Report

Respected Sir,

I, Advocate Abhishek Singh, S/o. Jitendra Kumar resident of Ganganagar, Birla Road, Siliguri, W.B. having mobile no. 9731177736, would like to bring to your kind knowledge about an incident which took place near Gyan Jyoti More, Durgapur in front of Traffic Booth at around 5:15 P.M. approximately. I was going towards Durgapur, Siliguri when a vehicle bearing registration no. W.B. 71 AD 3640 approached towards me from opposite direction. Thereafter the driver of the vehicle most rudely behaved towards me. We had a verbal exchange and all of a sudden he got off the vehicle with an intent to assault me and verbally abused me by using slang, more specifically "Bokachoda". After inquiring about the vehicle I have found that this vehicle is registered in the name of M/s Durga Automotives Pvt. Ltd. and was presently under the service of G.D. Goenka School. The name of the driver is Sri Gopal Chatterji whose mobile no. is 9002686640. Upon asking for apology from him he has threatened me that this is his place of birth and he will deal with me appropriately.

So he subjected me through mental pain and agony by uttering obscene words, commenting on place of birth, by defaming me, assaulting me by criminal intimidation, besides moral abuse directed towards me. Hence I request you esteemed office to kindly initiate appropriate action under provisions of Criminal Procedure.
