I then immediately tried calling the aforesaid unknown mobile no. 7866978583 but the no. is "Out of Range", than I understood that I was fraud by this unknown miscreant.

I am an old retired person and this amount of Rs. 50,000/- is my hard earn money which is deducted from my aforesaid pension bank account, so I request u to look into the matter and also to take necessary legal action against the person and recover my said Rs.
