
Respected Sir,

With due respect I, Bharati Singha Dutta W/o Syatajit Dutta , D/o Parimal Singha of Maicheal Madhusudhan Colony P.S- N.J.P, P.O Sahudangi Halt, Dist- Jalpaiguri, would like to draw your kind attention to the following affect that my marriage was solemnized On 10.12.2020 at the house of Parimal Singha infront of my parents, relatives, friends and well wisher. At the time of our marriage my father gave me furniture like Sofa, Freeze, Dressing table, TV, bedding, almira, wearing apparels, gold ornaments amounting Rs. 6 Lakh utensils( kasha , Pital and steel) as per demand of the aforesaid persons. From the date of inception of matrimonial house, the aforesaid in laws started to torture me by several means due to want of more dowry, it may be noted that at the time of marriage my father in law and sister-in-law demanded Rs. 1.5 lakh otherwise they will break the marriage accordingly, that amount was paid by taking loan from different relatives due to public disgrace. In my matrimonial house they treated me as a maid servant and did not provide proper food. And my husband was always busy with his cell phone to contact with another lady if I raised any objection then my husband used to beat me mercilessly even my husband not interested to build up any sexual relation with me and he always told me he have another lady for the same. And my father-in-law and mother-in-law always confined me in a room and was not allow to contact with my parental house. And my mother-in-law always used to threat me by saying that 'Bhikarir Bhaccha besi barabari korley gola tipe mere jhuliyे debo aar aye barir kotha kauke bola jabe naa, thana police e bhoie aamader nei " That every time my husband along with my father-in-law and mother-in-law used to threat me by saying that " Aiy barite tor besi din bhaat neyi hoie toke mortey hobe noy toke baaper bari jaiyte hobe". Ultimately On 17.03.2021 my husband took me in my parental house by saying that after 2 or 3 days he will take me in my matrimonial house but till now he did not contact me by any means. It may be noted that during my stay the aforesaid person created pressure upon me to bring Rs. 2 lakhs from my parents otherwise they will return me to my parental house. The aforesaid person torture me due to want of dowry. That my all Stree Dhan properties are detained by them. They may further ne noted that during my stay in my paternal house my guardians are several times tried to settled the dispute but they are too adamant are asked Rs. 2 lakh in lieu of stay in matrimonial home of them.

Therefore, you are requested to look into the matter seriously and take some major legal action in this regard against the aforesaid persons as per law.
