I, **Sri. Hirok Roy**, (Mobile No.-7699257062), aged: 31 years,  
S/O, Sri. Biren Roy, Resident of: Matri Sadan Hospital, Satyajit Roy  
Road, Ward No. 23, Subhas Pally, Siliguri, District:- Darjeeling., beg  
to report you the following facts:-

1. That on 08/04/2021 at evening around 7p.m ,I was in  
market then my wife along with my 9 years old minor son  
leaved from my house without prior intimation to me.
2. That thereafter, I was called for several times to my wife's  
mobile phone but eventually said phone was switched off.  
Thus, at that moment, I was called to my wife's father's  
house but her father told that "she could not come to his  
house".

After that, I was called to many persons /relatives for searching of my wife and minor son but everybody said that they could not come to their house or could not see themselves.

It is pertinent to mention here that, before few months, my wife has already taken this type of attempt but was in vain as because after few hours, while my wife was leaved from my house, then she was compelled to come before her matrimonial house with the intervention/help of her father.

As a matter of fact, my wife's behavior is not normal at all. Most of the time, she used to pick up quarrels with me without any cogent reason, hence , previous night at 7 p.m; i.e. on 08/04/21, she leaved along with my said minor son from my dwelling house without any reason or prior intimated to me.



That since 08/04/21, when I returned back to my said house and seen that my wife and my said minor son not there then I am living under lots of mental agony, pain and immense distress condition at that present moment.

I, therefore request you to kindly take necessary action and find out my wife and my said minor son as early as possible.
