In producing here with the accused person namely- Bindeswar Sah(58) yrs. S/O-Late Thakur Sah of Santoshi Nagar, Near Nepali Busty, Ward No-5, P.S-Siliguri, Dist. Darjeeling, along with seized (i) 15 (Fifteen) bottles of Himalaya Gold 60 up Country spirit containing 600 ML in each bottle mentioning M.R.P of Rs- 100/- in each bottle i.e. total amount of Rs-1500/- (One thousand Five Hundred) in which 01 (one) bottle taken as sample and marked as Exhibit- "A-1".

I beg to report that today i.e. On 19-04-21 while performing special raid against illegal alcohol, at 16.15 hrs. I received a source information that one person namely- Bindeswar (58) yrs. S/O-Late Thakur Sah of Santoshi Nagar, Near Nepali Busty, Ward No-5, P.S-Siliguri, Dist. Darjeeling, is selling huge alcohol in side Pan shop at Santoshi Nagar More, Burdwan Road, Siliguri, SPC. of the accused person, P.S-Siliguri, Dist. Darjeeling without any valid license and documents in higher price than the actual value for his illegal gain. Accordingly I informed the fact to I/C, Siliguri P.S over telephone who directed and instructed me to verify the veracity of the information. Accordingly, myself along with force left for at Santoshi Nagar More, Near Burdwan Road, Siliguri, SPC, to verify the veracity of the information vide Khalpara TOP GDE No -903/21 Dated- 19-04-21. After reaching at Santoshi Nagar More, Near Burdwan Road, Siliguri, SPC, at 18.35 hrs and as shown by the source, I found the above noted person is selling liquor and selling secretly in side Pan shop at Santoshi Nagar More, Burdwan Road, Siliguri, SPC. to different persons and seeing the Police party the above noted person try to flee away but we managed to intercept him. On being asked he disclosed his identity as mentioned above. During search, I could recover the above noted alcohol kept in a gunny bag. During interrogation he admitted that he is selling alcohol for his wrongful gain. On demand he failed to produce any valid license or documents in support of such business. During local enquiry it has been confirmed that the above noted person is selling alcohol illegally since long. Accordingly, I seized (i) 15 (Fifteen) bottles of Himalaya Gold 60 up Country spirit containing 600 ML in each bottle mentioning M.R.P of Rs- 100/- in each bottle i.e. total amount of Rs-1500/- (One thousand Five Hundred) in which 01 (one) bottle taken as sample and marked as Exhibit- "A-1". The above noted recovered I.D. liquors under proper seizure list duly packed, sealed and labeled in presence of witnesses and took their signature in the seizure list and labels and also arrested the above noted accused person U/5- 41 Cr.P.C under proper memo of arrest and observing all the formalities of arrest. The entire search and seizure process completed in between 18.35 hrs to 19.25 hrs on 19-04-21.

Under the circumstances one specific case may kindly be started against the arrested accused person namely: - Bindeswar Sah (58) yrs. S/O-Late Thakur Sah of Santoshi Nagar, Near Nepali Busty, Ward No-5, P.S-Siliguri, Dist. Darjeeling for the possessing and selling alcohol illegally and arrange for its investigation.
