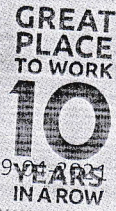
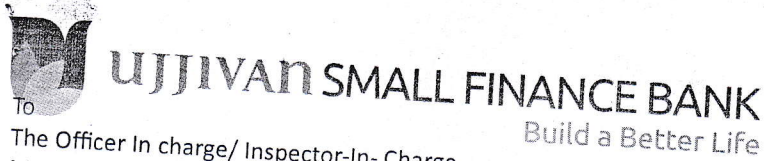

Sub: Prayer for lodge a complaint against attempt to commit ATM burglary by some unknown miscreant at Ujjivan Small Finante Bank, Shiv Mandir Branch (Medical More).

Sir,

With due respect I beg to state that I am Satyam Majumder, S/O- Lt. Mrinal Kanti Majumder working as Branch Manager at Ujjivan Small Finance Bank Ltd, Shiv Mandir Branch. On 18-04-2021 at around 3:09 am, one unknown person entered in the ATM of Shiv Mandir Branch (ATM ID – URH36270) located at Medical More , Kadamtala , Near Syndicate Bank , PIN.734011 . Face was covered with mask . Post entering the ATM the unknown person tried to tamper with the Cheque drop box & ATM .

Our surveillance was active and on receiving information from the central monitoring service, we have immediately informed to Matigara Police station (Darjelling). Accordingly, police acted very promptly and reached at the ATM and investigated the matter. But before arrival of us and the police personal the unknown miscreant escaped from the place of occurrence under the cover of darkness. in order to commit burglary.

Therefore, I request you to lodge a FIR against the unknown miscreant and to take necessary action as per law.
