Sir,

I beg to inform you that today at about 5 p.m. while I along with my friends were gossiping by the side of the road at Sukanta Pally near Shaktigarh Vidyapith School under Ward No. 32, Smt. Sikha Chatterjee, the BJP candidate of Dabgram-Fulbari Assembly Constituency and Shankar Sengupta, Sunil Mohanty, Rajesh Pratap Singh, Manik Bhadra, Abhijit Sarkar (Bulon) and others abused us with filthy languages and shouted that we are the thieves of Trinamool Congress. We protested for such stigma and Smt. Sikha Chatterjee and her associates gheraoed us and assaulted us. Therefore, I request you to save us from the high handedness of Smt. Sikha Chatterjee and her associates and to take necessary legal steps.
