I, **LALITA DAS**, W/O Anup Ghosh, Resident of C/O. Jyoti Bikash Dutta, N.S. Bose Road, Subhashpally, P.O. & P.S. Siliguri, Dist - Darjeeling, do hereby want to inform you as follows :-

1. That I was married with Anup Ghosh.
2. That my brother namely Bhojon Kumar Das was married to **Tamanna (Das) Sarkar**, D/O Kamal Sarkar, on 24.11.2020 according to Hindu rites and customs at the parental house of my sister in law and after marriage my brother and sister in law started to live together as husband and wife along with my mother and other family members at Netajipara, Ghogomali, P.O. - Ghogomali, P.S. - Bhaktinagar, Dist - Jalpaiguri.
3. That I heard that after few days of marriage my sister-in-law and her relatives began to misbehave with brother, mother and me as my brother could not earn huge money, for that my Sister-in-law, **Tamanna (Das) Sarkar**, use to be quarrel with my brother and mother and every now and then used to go in her relative's house without intimating my mother and my brother.
4. That I heard that my sister-in-law gradually developed complex upon my brother and started ignoring my brother and other family members in every respect and started to be quarrel with my brother and other family members without any realm or reason.

5. That I heard that whenever my brother and mother tried to protested against this kind of behavior of my sister-in-law i.e., **Tamanna (Das) Sarkar**, she would immediately began to abuse my brother and my mother in filthiest languages like swine, fool etc and throw utensils etc and used to demand for a separate rented house otherwise she will become more evil with my brother and me. She often used to move out of the house without informing anyone and whenever my brother and mother try to convince her upon her insane activities she used to be very furious and always threatened my brother and my mother that she will leave the house if my brother did not shift to another house separately. my mother and my brother were passing their days bearing all the torture of my sister-in law with a hope that everything will be alright.
6. That it is mentioned here that I am living separately from mu brother and mother since my marriage in my above mentioned address along with my husband but my sister in law always use to abuse me in filthy languages whenever I went to visit to see my mother in their rented house.
7. That my brother told me that my sister in law never used to take care of my brother and moreover my sister in law always used to throw filthiest languages upon my mother. Subsequently my brother told me that my sister in law started to create pressure upon my brother to shift in a separate rented house otherwise she will be more quarrels with my brother. Moreover my above named sister in law always used to threaten my brother and other family members that she will implicate my brother and other family members in false cases.
8. That whenever my sister in law abuse me with filthy languages, the mother of my sister in law namely Sujata Sarkar and father namely Kamal Sarkar along with the grandmother of my sister in law always used to instigate my sister in law to create pressure upon my brother to stay separately leaving my widow and distress mother and also influence my sister in law to implicate us in false cases by using her political influences.

That my brother and mother was severely attacked by my sister in law, her mother, her grandmother and they forced my brother to sit to a Shalishi Sabha in presence of Political Party members as because the mother of my sister in law is active Party member of the ruling Party and always threaten my brother and mother that she will destroy the life of my brother and mother by implicating them by false cases by using the power of ruling Party.
10. That upon fear my brother and mother took shelter in my above mentioned house, today on 21.04.2021 the sister in law, her mother, her grand mother and some of Trinomul Party workers of Dabgram II, Fulbari Panchayet, one of them namely Sujit Basak started to chaos in front of my rented house, abused me and my brother, mother and my husband with utterly filthy languages and forcefully entered into my rented house and ransacked my rooms, beat me mercilessly by pulling my hair and push my head into the wall, I was injured by the said assault and was treated in Siliguri District Hospital.
11. That the above named persons also assaulted my husband and my minor son and also looted the house and threatened me that if my brother and mother will not sit on the Shalishi Sabha organized by the Political persons at Ashigarh then they will destroy my life as well as the life of my husband by implicating false cases against us.
12. That due to my sister in law's continuous threatening to me and my family, my family life has become jeopardize.
13. That my sister in law's above mentioned acts and conducts are creating such situations that I have to face great mental torture and forced to live under the threat of repetition/ escalation of the acts of domestic violence.
14. That being an helpless lady I am passing my days in a distress condition for the above mentioned activities of my sister in law as our social prestige is already been destroyed and we became unable to pass our normal life.

Therefore Sir this is my humble request to you that kindly look into this matter and may protect me and my other family members from the mala fide intention of my sister -in -law who is very much desperate and is in very much in action to implicate me and my other family members in false cases and destroy our family prestige in society.
