Respected Sir,

I, **Saheda Khatoon**, Wife of Md. Saibul, residing at Vivekananda Nagar, Ward No.42 of S.M.C., P.O. Salugara, P.S. Bhaktinagar, Dist. Jalpaiguri, do hereby lodge a complaint against 1) Md. Belal, Son of Md. Mainul, 2) Manora Begam, Wife of Md. Mainul and 3) Md. Izhaar, Son of Not Known, all are resident of Vivekananda Nagar, Ward No.42 of S.M.C., P.O. Salugara, P.S. Bhaktinagar, Dist. Jalpaiguri, to the effect that on 19-04-2021 at about 9:15 am, abovenamed persons came to my parental home and physically assaulted me with fist and blows, and physically assaulted my husband with bricks and they also throttled the neck of my younger brother, named Md. Ramzaan and the above-named person took away my golden nose top.

Due to their physical assault, I sustained bleeding injury from my nose, left hand and on my person, my husband sustained injury on his right shoulder and my brother sustained injury on his neck and right wrist.


I could not lodge the complaint against the abovenamed persons in due time as my child is about 3 ½ years and suffering from illness and there is no one to look after him.

So, therefore, I humbly request your goodself to take necessary legal action as per provision of law against the abovenamed persons at an earliest.

I shall remain ever grateful for the needful and be obliged thereby.
