Sir,

I Sree Sandeep Poddar s/o. Sri Rajkumar Poddar residing at Sevoke Road, Siliguri, P.O.&P.S.Siliguri, Dist. Darjeeling beg to state as follows :-

1. That I am attorney of Suresh Agarwal who owner in possession of land measuring 4 Katha recorded under Mouza- Dabgram, P.S. Bhaktinagar, Dist-Jalapaiguri under Khatian No.R.S.191/1,191/2, L.R.1316, Plot No.R.S.92,35, corresponding L.R.198, by way of registered Sale Deed being No. 2092 year 2019 and after purchased constructed boundary wall over the land and one katcha Ghar inside the land and recorded his name in L.R.Khatian and possession the same since purchase without any interruption from any corner.

2. That last night on 21-4-21 at about 10.30 P.M. some miscreants under the leadership of Pradip Kumar Mandal s/o. Not Known, Tushi Mandal w/o. Pradip Kumar Mandal both residing at Ghogomali, P.O.Rabindranagar, P.S.Bhaktinagar, Dist. Jalpaiguri all on a sudden the aforementioned persons being wrongfully trespass our land with iron rod, sword, lathi & shricks and started assaulting our Night Guard with lathi & sticks resulting tremendous pain in their bodies, and broken the some portion of boundary wall and demolish structure where kept 50 beg cement, 300 kg. different type of Iron rod and stolen the said things whose worth Rs.35,000/- (Thirty Five thousand rupees) and on our Night Guard cry the neighbor peoples came to land then the aforesaid person fled away with such stolen things to their Pickup Van.

3. That the above mentioned miscreants and their associates are very dangerous and desperate in nature. They do not hesitate to take law in their own hand.

In these circumstances, I request you to take necessary legal step against the aforementioned persons and to take appropriate steps in which to recover the stolen property from the custody of aforesaid wrongdoers by taking them in police custody and oblige thereby.
