& my CCTV camera's was in play condition after that I play
in & find the playback of find that on 16/04/21 near about 3:22
am a thief was entered in my quarter after that he was
off the camera's & in play. When I search my room I found that
01 no. of gold chain, of pair of earrings, Rs. 5000/- cash & 01
no. of gas cylinder (empty) was missing from my quarter, when
I again check the footage of CCTV I found that the thief was
entered my home with a sharp knife. It was completely creepy
condition for me.

Therefore, I would like to request you please kind attention
to look after the internal matter & take fruitfull action against
it. I hope the lawyer will certainly stand to you in a good
favourable manner. It is a highly ~~serious~~ serious offence
& disturbed the public safety. I will highly obliged for that.
