Khatian No. 786 , R.S. Plot No. 184 Sheet No. 11, J.L. No. 03 , Mouza-Binnaguri, Pargana-Baikunthapur, Police-Station-New Jalpaiguri (earlier-Bhaktinagar), District-Jalpaiguri.
