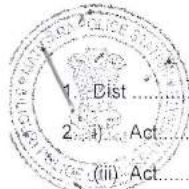

Sir,

In producing herewith two (2) arrested accused persons namely (i) Rejjak Ali (57), S/O- Lt. Sikandar Ali of Raghobpur PO - Altapur, PS- Karandighi, Dist. Uttar Dinajpur and (ii) Jahangir Sk (40), s/o-Abdul Latif Sk of Srirampur, Mominpara, PO - Bahadurpur, PS- Kaliachak, Dist- Malda (not verified) along with the following articles under proper seizure as per seizure list;

- a) One transparent plastic packet containing 1000 grams brown sugar kept in a multi colour nylon hand bag being carried by accused Rejjak Ali and marked as Exhibit-'A',
- b) One transparent pouch containing 20 grams brown sugar taken as sample from exhibit "A" for examination and marked as Exhibit 'A-1'.
- c) One transparent plastic packet containing 1000 grams brown sugar kept concealed on waist under trousers of accused Jahangir Sk and marked as Exhibit- "B"
- d) One transparent pouch containing 20 grams brown sugar taken as sample from exhibit "B" for examination and marked as Exhibit "B-1".
- e) One multi colour nylon hand bag in which exhibit "A" was kept and marked as exhibit "C".
- f) One white coloured Xylo car having number plate. WB 66 H 2170 and marked as exhibit "D".

I, SI Shekhar Adhikary, S/O- Lt. Sonatan Adhikary of Matigara Police Station, Siliguri Police Commissionerate do hereby lodged this written complaint against above noted (i) Rejjak Ali (57), S/O- Lt. Sikandar Ali of Raghobpur PO - Altapur, PS- Karandighi, Dist. Uttar Dinajpur and (ii) Jahangir Sk (40), s/o- Abdul Latif Sk of Srirampur, Mominpara, PO - Bahadurpur, PS- Kaliachak, Dist- Malda (not verified) to the effect that today on 23.04.2021 at about 14.25 hrs I received a specific source input that two persons on a Xylo vehicle having number plate WB 66 H 2170 are coming from Islampur side with huge quantity of brown Sugar for delivering the same to their designed customers at Matigara and its adjacent areas. The matter was diarized in Matigara PS GDE No. 1696, Dt- 23.04.2021 and subsequently, I informed the matter to the Officer-In- Charge, Matigara Police Station in written and being directed myself along with ASI Nitai Mandal, Const- 1035 Santosh Rabidas, CV- 387 Sukumar Barman and CV- 155 Sukumar Das all of Matigara PS, SPC along with investigation kit left for By Pass More, under PS- Matigara by govt. vehicle to verify the veracity of the information vide Matigara PS GDE no. 1697, Dt- 23.04.2021 and M.C.C No- 797/21 Date- 23.04.2021.

Under this circumstance any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidence or facility for the escape of the offender.

On way to By Pass More, I contacted two persons namely (i) Md. Irsad Alam(20), S/O- Md. Jabed Alam of Matigara Bazer, PS- Matigara, Dist- Darjeeling and (ii) Shibu Singh(32), S/O- Lt. Tapan Singh of Tumba Jote, PS- Matigara, Dist- Darjeeling and make them aware of the information in hand and requested them to act as witness, if any search and seizure would be made necessary upon which they agreed. Thereafter we along with the independent witnesses reached at By Pass More, at 14:55 hrs and started waiting for the vehicle. After sometimes, we detained one Xylo vehicle having number plate- WB 66 H 2170 at By Pass More and found above noted Jahangir Sk was on driving seat and Rejjak Ali was found seating beside driver's seat. Thereafter, we disclosed our identity and the information in hand and stated them that they will be searched in person for the purpose. At this, they after disclosing their identity as noted above admitted that they have illegally possessed brown sugar in their possession for selling the same to their designed customers as per requirement. I then gave them option in writing whether they wanted to be searched in presence of an Executive Magistrate or by any Gazetted Officer. Then they agreed to be searched in presence of any one of the above. I also offered the independent witnesses and the accused persons to search our Police Party as per provisions but, they did not search the police party.

Accordingly, I informed the matter to O/C Matigara PS and as per his kind order, I informed to Sri Rajen Chhetri, Assistant Commissioner of Police, ICP, Fulbari, Siliguri Police Commissionerate detailed for acting as Special Executive Magistrate of SPC for the day, regarding the interception of the accused persons suspected to be possessed Brown Sugar and requested him to come at By Pass More to remain present and to supervise the search and seizure. Accordingly at 15:50 hrs Sri Rajen Chhetri, Assistant Commissioner of Police, ICP, Fulbari, Siliguri Police Commissionerate arrived at the spot as Special Executive Magistrate, SPC and in presence of two independent witnesses I searched the detained persons as well as their belongings following all formalities keeping their decency and recovered the above noted articles from the exclusive and conscious possession of accused Rejjak Ali and Jahangir Sk. On demand in presence of Sri Rajen Chhetri, Assistant Commissioner of Police, ICP, Fulbari, Siliguri Police Commissionerate acting as Special Executive Magistrate, SPC the detained persons namely Rejjak Ali and Jahangir Sk failed to produce any valid document in support of possessing of the brown sugar.

Thereafter, I weighted the recovered packets with the weighing instrument and found 1000 grams of brown sugar kept in a transparent pouch which was found in a multi colour nylon hand bag being carried by accused Rejjak Ali and marked as Exhibit-A and 1000 grams of brown sugar kept in a transparent pouch which was found kept concealed on the waist under trousers of accused Jahangir Sk and marked as Exhibit- "B". I also taken 20 grams of Brown Sugar from each packet as sample for examination and marked as "Exhibit A-1" and "Exhibit B-1". Then, I seized the above noted articles at the spot under proper seizure list and also labeled and sealed all the articles in presence of Sri Rajen Chhetri, Assistant Commissioner of Police, ICP, Fulbari, Siliguri Police Commissionerate acting as Special Executive Magistrate, SPC and independent witnesses and accused persons and also obtained signature of the above noted witnesses and the Special Executive Magistrate, SPC and put my signature too and also acknowledged by the accused persons. The whole process of seizure was made in between 16.00 hrs to 16.55 hrs.

Being further asked the apprehend persons namely Rejjak Ali and Jahangir Sk admitted in presence of Sri Rajen Chhetri, Assistant Commissioner of Police, ICP, Fulbari, Siliguri Police Commissionerate and other witnesses that they have procured the brown sugar clandestinely from Kaliachak, Malda for the purpose of selling the same in high rate to their designed customer for their personal gain by illegal means. They also disclosed that they have been dealing in such business of procuring and selling of brown sugar illegally for last few months.

From the above noted facts and seizure of incriminating articles it is quite evident that the accused persons namely Rejjak Ali and Jahangir Sk are involved in procuring and selling of brown sugar illegally contravening the norms of NDPS Act.

Then, I arrested the above noted accused person namely Rejjak Ali and Jahangir Sk after observing all formalities and informing the ground of their arrest and issued necessary Memo of Arrest.

Under the above circumstances, I pray to you that a specific case under proper section of law may kindly be started against the accused persons namely (i) Rejjak Ali (57), S/O- Lt. Sikandar Ali of Raghampur PO - Altapur, PS- Karandighi, Dist. Uttar Dinajpur and (ii) Jahangir Sk (40), s/o- Abdul Latif Sk of Srirampur, Mominpara, PO - Bahadurpur, PS- Kaliachak, Dist- Malda (not verified) and arrange for its investigation.
