Dear Sir,


I, Manoj Agarwal, resident of C-11/08, Uttorayon, Matigara, would like to lodge a complaint & F.I.R. against a theft which took place last night somewhere around 2:40am to 3:00am in my house. The thief entered my house through the balcony of the first floor of my house into my son's room and stole 2 mobile phones worth about Rs.40,000/- and cash of about Rs.40,000/-. A Police Team had visited my residence at about 3:15am after I had lodged a telephonic complaint.

Sir, I would like to bring to your notice a slew of thefts which have been happening in especially C-Block area of Uttorayon in the recent past. In the past 4 or 5 months there have been repeated incidents of thefts in the C-Block area of Uttorayon and this has left all of us here live in fear.

I request you on behalf of my entire neighbourhood of C-Block to start patrolling in the C-block area of Uttorayon during night time so that we may feel secure and such incidents do not happen again. 




