
Respected Sir,

With due respect I, **SRI PANKAJ KUMAR PASWAN**, Son of Late Parmanand Paswan, Resident of 1 No. Panchanan Colony, Ward No. 1 of S.M.C., P.O. & P.S. Pradhan Nagar, Dist. Darjeeling, would like to lodge this written complaint to the effect that that **MISS PAMMI KUMARI PASWAN** is my minor daughter and my said daughter is aged about 16 years. My daughter is a student of Class-X of Bharti Hindi High School. As usual course, on **25.04.2021, at about 06.30 A.M. / 07.00 A.M.**, my said daughter went away towards her private tutor at Diesel Colony, P.S. Pradhan Nagar, Dist. Darjeeling from my residence and after completion of the Private Tuition, she supposed to return back home at 09.00 A.M. but even after elapse of 09.00 A.M., when my daughter did not return back to our house, I along with my family members have searched to find out her in all possible places but we failed to locate and recover her. Later, we came to learn that when my daughter was proceeding towards her private tutor, one Rana Baidya @ Babu, Son of Late Raju Baidya of 1 No. Panchanan Colony, Ward No. 1 of S.M.C., P.O. & P.S. Pradhan Nagar, Dist. Darjeeling has kidnapped my minor daughter forcefully against her will and concealed her to some unknown places with an intention to marry her against her will. It is also to be mentioned here that previously, said Rana Baidya @ Babu had make an attempt to kidnap my daughter and threatened her with dire consequences.

I, therefore, request you to kindly take necessary legal steps against said Rana Baidya @ Babu and his associates who are involved in the above crime and recover my daughter from the hand of the said person/s and obliged thereby.


