In producing herewith 07 (Seven) arrested accused persons who disclosed their identity as (i) Subodh Mandal (21), S/O Swapan Mandal of Ghugumali, Niranjan Nagar, PS-Bhaktinagar, PS-Jalpaiguri, (ii) Bishal Roy (19), S/O Nitta Roy of Shib Nagar, Salugara, PS- Bhaktinagar, Dist-Jalpaiguri, (iii) Manik Roy (19), S/O Samesh Roy of Do, (iv) Pradip Roy (45), S/O late Katak Lal Roy of Pradhanpara, Salugara, Ward No- 42, PS-Bhaktinagar, Dist-Jalpaiguri, (v) Raju Kumar Sah (24), S/Okailash Sah of Nagrakatta, Charchariya More, PS-Nagrakata, Dist-Jalpaiguri, (vi) Kaushar Alam (23), S/O Ahmed Hussain of Milik Busty, Bihar, Puthiya, Dist- Kishanganj, State-Bihar & (vii) Biswajeet sarkar (38), S/O Manindra Sarkar of Vivekananda Nagar, Ward No-42, PS-Bhaktinagar, Dist-Jalpaiguri under proper arrest memo .

I, SI. Md. Ziaul Hoque of Bhaktinagar PS, SPC do hereby lodge complaint against the above noted persons, to the effect that 25.04.2021 at about 14.30 while I along with officer and force were performing patrolling duty in c/w COVID-19 at Sevoke Road near Cosmos Mall under Bhaktinagar, PS, Dist-Jalpaiguri vide Bhaktinagar PS GDE No 2097 dated 25.04.2021. At about 17.05 hrs and during my patrolling duty found the above noted persons were moving without any mask and without any reason. Thereby making unnecessary gathering at Cosmos Mall, Sevoke Road, PS-Bhaktinagar, Dist-Jalpaiguri. On being asked the above noted persons stated that they were well aware of pandemic Covid-19 situation and they supposed to wear face mask. Further I requested them to wear Mask and maintain the social distance but they did not pay any heed. Hence they all violated the order of Govt. of India duly promulgated in order no 40-3/2020-DM-I (A), Govt. of India Ministry of Home Affairs Dated 24.03.2020. They all also violated the order of Govt. of India duly promulgated in order no 40-3/2020-DM-I (A), Govt. of India Ministry of Home Affairs Dated 24.03.2020 and MHA (Internal Security Division) vide no- 11034/01/02022-IS-IV Dt. 27/04/20 & Govt. of WB order No - 79-CS/2020 Dated- 12.04.2020 and advisory issued vide no- 715-Home 9Cons)/RIM (Cons)-92/2021 Dated- 17.04.2021 and Memo No- 486-CS/2021 Dated- 24.04.2021. The above noted persons have intentionally refused to comply with the order of Govt. of India and Govt. of West Bengal duly promulgated in view of break- out of Pandemic COVID- 19 throughout the Country. Finding no any other alternative I arrested them under proper memo of arrest after explaining the charge against them.

Under the above circumstance I request you that a specific case may kindly be started U/S 188/269/270 IPC R/W Sec 51(b) Disaster Management Act. 2005 against the above noted 07(seven) arrested accused persons and arranged proper investigation of the case.
