Sir,

With due respect and in producing herewith 08(Eight) accused persons namely (1) Md Raj (18) S/o Md Raja of Champasari Anchal ,(2)Rajkumar Sah(18) S/O Mithilesh Sha of Darjeeling more ,Shibnagar ,(3) Kumaran Roy(19) S/O Bokul Roy of Promod nagar ,Champasari all of P.S-Pradhannagar,Dist.Darjeeling (4) Md Monu (26) S/O Md Hatim of Jyotinagar, W/no.4,P.S-Siliguri,Dist.Darjeeling ,(5)Anil Kumar (42) S/O Deep Narayan Sha of Check Post ,P.S- BKN ,Dist.JPG (6)Jhantu Mahato (29) S/O Dipen Mahato of Choto fagri P.S- BKN ,Dist.JPG(7)Anikat Sahani(18)S/O Mukesh sahani of Prakash nagar ,w/No.43 P.S-BKN ,Dist.JPG& (8) Anil Pandey 945) S/O Ram Upek Pandey of Prakash nagar P.S- BKN ,Dist.JPG under arrest .

I beg report that today on 25.04.2021 at about 15.05 hrs in course of Special Mobile Van duty vide PDN PS GDE No. 1410 dtd.25.04.2021 myself along with PSI Kalyan Saha,ASI Binod Jha CV/ 405 M. Chichbaraik and others had been to Champasari more area under PDN PS and found the above noted persons roaming at the area without wearing mask, not maintaining social distance norms and splitting in the public place violating the Govt. Order No. 79-CS /2020 dtd 12.04.2021of Gove of West Bengal and Home and Hill Affairs Department of the Govt of West Bengal ,vide notification number 237-I S.s /2M-24/2020 dtd03.06.2020 and Memo no. 486-CS /2021 dtd.24. April,2021 of Chief Secretary & Chairman ,State Executive Committee WBSDMA .Accordingly, the above noted persons was detained on being interrogated disclosed their identity as above and further failed to give any satisfactory answer regarding their such activities in that area rather they refused to comply with direction of the Government regarding spreading of COVID-19. Hence, I arrested them u/s- 41Cr.P.C , issuing copy of Memo of Arrest and informing the ground of their arrest .


Therefore, I pray before your good office that a specific case under proper section of Law may kindly be started against the above noted accused persons and arrange for its investigation.
