Sir,

With due respect and in producing herewith 04(Four ) accused persons namely (1) Mukesh Kr Eam (31) S/O Ram Avtar Ram ,C/O Bijoy Ram of Dharma nagar ,Coollipara (2)Mahabir Sha (60) S/O Lt Balli Sha of Gurung Busty Bazar ,(3)Dinesh Ram (42) S/O Dahor Ram of Rajendar nagar Cooli para all of P.S-Pradhannagar,Dist.Darjeeling & (4) Bablu Khan (21) S/o Hasnian Mia of Jadhali ,Batna ,P.o- Amror,P.s- Marahra,dist. Chapra,Bihar under arrest .

I beg report that today on 26.04.2021 at about 12.25 hrs in course of Special Mobile Van duty vide PDN PS GDE No. 1463 dtd.26.04.2021 myself along with ,ASI Moksud Ali C/ 1119 Tanmoy Roy & C/ 1415 Chandan Biswas had been to Siliguri Junction area under PDN PS and found the above noted persons roaming at the area without wearing mask, not maintaining social distance norms and splitting in the public place violating the Govt. Order No. 79-CS /2020 dtd 12.04.2021of Gove of West Bengal and Home and Hill Affairs Department of the Govt of West Bengal ,vide notification number 237-I S.s /2M-24/2020 dtd03.06.2020 and Memo no. 486-CS /2021 dtd.24. April,2021 of Chief Secretary & Chairman ,State Executive Committee WBSDMA .Accordingly, the above noted persons was detained on being interrogated disclosed their identity as above and further failed to give any satisfactory answer regarding their such activities in that area rather they refused to comply with direction of the Government regarding spreading of COVID-19. Hence, I arrested them u/s- 41Cr.P.C , issuing copy of Memo of Arrest and informing the ground of their arrest .

Therefore, I pray before your good office that a specific case under proper section of Law may kindly be started against the above noted accused persons and arrange for its investigation.
