With due respect, I am producing herewith the accused persons namely (i) Anowar Hussain (47 yrs) S/O Nazir Ali and (ii) Phulchand Ali (20 yrs) S/O Ranjan Ali both of Vill+PO- Rowmari Pathar, PS- Tarabari (Bohori) Dist.- Barpeta, Assam under arrest and the following articles under seizure. The ground of arrest duly been communicated with

1. One Truck displaying number plate AS/25/EC/0733.

2. 35 (Thirty five) numbers of blue colour plastic container (Drum) each container (drum) containing 200 ltrs of Raw Spirit i.e. total 7,000 (Seven thousand) Itrs of Raw Spirit marked as Exhibit- A, B, C, D, E, F, G, H, I & J, from which 500 ml of Raw spirit taken from each container and marked as A-1, B-1, C-1, D-1, E-1, F-1, G-1, H-1, I-1, & J-1

I beg to report that loday i.e. on 27.04.21 at 14.15 hrs I received a secret source information that one truck displaying number plate AS/25/EC/0733 loaded with huge quantity of raw spirit with a view to sale the same in Bihar for the purpose of preparing illicit I/D liquor. Accordingly, diarized the fact in the General diary vide NJP PS GDE No 1387 dated 27.04.21 and informed the fact to you. As per your kind direction and instruction myself along with force left for Fulbari Toll Plaza to work out the information in hand. On the way to the spot I called two independent witnesses namely (i) Soumya Bikash @ Bubai Ghosh S/O late Jyoti Prakash @ Mantu Ghosh of Purba Dhantala, PS- NJP, Dist.- Jalpaiguri and (ii) Sukamal Sengupta S/O late Subir Sengupta of Shaktigarh Road No-3, PS- NJP, Dist.- Jalpaiguri and disclosed our identity and informed them about the information in hand and requested them to accompany with us in whole process during search and seizure. At about 14.45 hrs we arrived at Fulbari toll Plaza and waiting for the said truck. At about 15.25 hrs we found that the said truck coming from Jalpaiguri side. We stopped the said vehicle at Fulbari Toll Plaza and found the above noted two persons boarded in the said vehicle. On being asked they disclosed their name and address as noted above. During interrogation they disclosed that the vehicle is loaded with 35 number of container each container containing 200 ltrs of Raw Spirit. On searched we found that total 35 numbers of blue colour plastic container (Drum) each container (drum) containing 200 ltrs of Raw Spirit. During interrogation they stated that they loaded the said raw spirit from Howli, Barpeta, Assam and was proceeding towards Dalkhola, Bihar. During further interrogation they disclosed that they along with the owner owner of the said vehicle is doing such type of business since long for their wrongful gain. On demand they failed to produce any documents in respect of 7000 ltrs of raw spirit in 35 numbers of blue colour container (Drum) loaded in the said vehicle. They also falled to produce any documents in respect of vehicle having registration number AS/25/EC/0733. On being further asked the above noted accused persons stated that the said raw spirit is using for manufacturing of illegal ID liquor in Bihar. There was sufficient reason to believe that the said vehicle is stolen one and the accused persons are carrying raw spirit from Assam to Bihar for their wrongful gain. Accordingly, I arrested them under proper memo of arrest and observing all the formalities of arrest and seized the above noted vehicle (truck) having registration number AS/25/EC/0733 loaded with 35 (Thirty five) numbers of blue colour plastic container (Drum) each container (drum) containing 200 ltrs of Raw Spirit i.e. total 7,000 (Seven thousand) Itrs of Raw Spirit under proper seizure list. The process of search, seizure and arrest made in between 15.55 hrs to 17.05 hrs.

Under the above noted fact and circumstances, I therefore pray before your kind honour that a specific case under proper section of law may kindly be started against the above noted arrested accused persons namely (i) Anowar Hussain (47 yrs) S/O Nazir Ali and (ii) Phulchand Ali (20 yrs) S/O Ranjan Ali both of Vill+PO- Rowmari Pathar, PS- Tarabari (Bohori) Dist.- Barpeta, Assam and the owner of the seized vehicle and arrange for its investigation.
