Hope you are doing good and good health!!!!!!

I would like to lodge a FIR against Mr. Ripan Ghosh, who joined Sudhriti Hotel & Restaurant in a Managerial Position on 11th Jan 2021 and was working in our organization, Mr. Ripan Ghosh took leave from $19^{th} - 24^{th}$ April for casting his vote. As per his job responsibilities he took money for purchase of several commercial products used in our Hotel & Restaurant (bed sheet, t-shirt for staff, commercial pizza oven, cutleries, etc) worth of Rs. 210000 approximately. He took cash from us to purchase the same of Rs. 200000.

He also collected payment from client named raju as per his conversation in Kolkata for Outdoor Catering of Rs. 600000 on behalf of Sudhriti Hotel & Restaurant (Images send by him in Whatsapp), also took photo copy of all necessary documents for the same of our organization (Trade license, GST registration, Food License, adhar etc).

He kept communicating with us until 24th April noon (14:57 hrs) after that he switched off his phone. He already confirmed us that he collected the cash for the same from the client. Everybody from our management tried to get in touch with him once he switched on his mobile number but he kept disconnecting our calls.

In the meanwhile we also tried to check his history from the past organization he worked as per his resume, Maharani Palace Cooch Behar & Jungle Book (Ms. Poulomi Gupta) confirmed us over telephonic conversation that he is a fraud and took money from several people in Coochbihar and assured them for guaranteed Government Job and cheated many people, the documents given by him were fake so they couldn't track him down, but they assured us for their support if we can track him down, so that somebody else is not being cheated like us.

On his joining he gave his residential details to us, after he left all documents were missing from our file as well.

It's my humble request to the concerned authority to please track him down as he might use our documents and misuse them. We think he is a fraud person who can bluff with several people and cheat them like us and many others. If we are able to find him he should be punished by the law.
