scrap shop.

Respected Sir/Ma'am,

I Rajendra Mahato s/o: Lt. Prabhu Mahato is a resident of
Gunung Busty, Siliguri, would like to bring your attention for
the following facts of the case regarding the theft which
occured today night i.e 27/04/2021 (between 12am to 7am) at
my scrap shop located at Dagapur.

Today when I opened my shop, I found that my backside
boundary of the shop was broken from which the thief entered
and robbed my shop. The stolen items include cast iron weighing
bars of 2kg, 5kg, 10kg and 20kg, scrap iron of around 70kg, aluminium
of 3kg and others items which I am unable to make a note.
Hence it is quite evident that it has been stolen by some
local miscreants. Often in six months once or twice my
shop is being robbed by some thief, making me financially unstable.

Therefore, I request you to register an FIR regarding the theft.
I shall be grateful to you, if you kindly investigate in
the matter and recover it.
