Dear Sir,

I, Malay Kr. Goswami, DE(E), S & LP Wing Darjeeling Region, WBSEDCL, do hereby lodge this written complaint against (i) Shibu Das (8637815427), S/o- Lt. Rajen Das at Majhabari, near Shantiniketan school, PS – Bhaktinagar, Dist.: Jalpaiguri and (ii) Amit Roy (9749909823) of Farabari, Nepali Basti to the effect that today about 15.00 Hrs. in pursuance of a secret information I along with (i) Sri Pinaki Majumder, SO, DRO, (ii) Sri Kausick Kumar Das, AE & SM, SP CCC and other supporting staff of Mobile Van had been to Majhabari and inspected the house of Shibu Das after issuing Notice and detected one service cable was connected from the LT Line like as regular line but he is not a consumer of the company. No meter was affixed in the premises. On further checking it is also found that said Shibu Das consuming Electricity Energy by using different electrical as mentioned in the Inspection Report by direct hooking from nearby LTOH Line by using 20mtr. (approx.) Service Cable and connecting the line in main switch directly without meter.

On further, enquiry, the user Shibu Das, made a clean breast confession to the effect that during last Durga Puja, 2020 as the instance of other he contacted with Amit Roy over phone with request to arrange his electrical line in his house. Amit assured him to electrical connection to be done shortly and in this respect he has collected Rs. 6000/- from Shibu Das. Then he made this hooking line and connected the line through main switch without meter and Shibu Das started consumption of electricity.

As they have committed offences as punishable u/s 135(1)(a) /150 of Electricity Act, hence I Seized Service Cable Approx. 20 mtr. (Approx.) A Cut-Out (32A), Main Switch, make MAX (32 A) and 1 no. electric switch board after preparing the seizure list duly signed by all. I also prepared an Inspection report and supplied copies of all documents.

Like to add here that said Amit Roy is an Ex-Contractual employee of this company and he left his job 6 months ago.

Shibu Das also gave a written statement to the above effect.

The physical load is 587 Watt/691 KVA and period of offence since 01.10.2020 to till today.

So, you are requested to register a case u/s 135(1)(a) /150 of Electricity Act, and arrange for its investigation.
