Hossain of DO (4) Sanjib Roy (19) S/O Goutam Roy of Telipara Kalua Colloney 1 No. Sukai jhora P.S Banarhat Dist :- Jalpaiguri (5) Amar Roy (23) S/O Anil Roy of Dhupguri Gowdam , Kathalbag , P.S Dhupguri Dist :- Jalpaiguri (6) Arjun Kumar Ram (21) S/O Baslal Ram of Ambadipa Post Goerkata P.S Banarhat Dist :- Jalpaiguri who have been arrested by me of the following ground:

I beg report that today on 29.04.2021 at about 21.05 hrs in course of Special Mobile Van duty vides PDN PS GDE No.1674 dtd.29.04.2021 myself along with other officer ad force had been to champasari anchal area under PDN PS and found the above noted persons were roaming at the area without wearing mask, not maintaining social distance norms in the public place violating the Govt. Order No. 79-CS /2020 dtd 12.04.2021 of Gove of West Bengal and Home and Hill Affairs Department of the Govt. of West Bengal ,vide notification number 237-I S.s /2M-24/2020 dtd 03.06.2020 and Memo no. 486-CS /2021 dtd.24. April,2021 of Chief Secretary & Chairman ,State Executive Committee WBSDMA. And annoying people by also playing high volume DJ box Accordingly, the above noted persons were detained on being interrogated disclosed their identity as above and further failed to give any satisfactory answer regarding their such activities in that area rather they refused to comply with direction of the Government regarding spreading of COVID-19. Hence, I arrested them u/s- 41Cr.P.C, issuing copy of Memo of Arrest and informing the ground of their arrest. And also seized a white colour bolero pick up bearing no WB 71 B 5716 with 5 pc of DJ box in different seize of JBL Company ,one generator of Atul Sakti company, 2pc Ahuja amplifier machine, one pc stabilizer of VK company 5000 watt, Palko light 4pc, leazure light 01 pc, Surfii light 02 pc, 01 pc DJ sound mixture Machine, 01 pc light mixture machine .

Therefore, I pray before your good office that a specific case under proper section of Law may kindly be started against the above noted accused persons and arrange for its investigation.
