Kumari Asharam, Siliguri wants to state you that :-

- 1) That I have been married to Rinku Saha and for last
few years due to family problem I am residing in my
parents home. My Matrimonial house is situated at
Haiderpara, Himachal Sarani, Near Branhha Kumari
Asharam.
- 2) That on 24/4/21 I went to my matrimonial house for
collecting some of my original document which has been
in possession of my husband Rinku Saha at about 3:30 PM.
- 3) That seeing my presence in my matrimonial home my husband
Rinku Saha, S/o Late Amal Krishna Saha, Fulali Saha, Surabhi
Saha, D/o Fulali Saha, Chottu Saha, brother of Fulali Saha,
Bulti (Maid of Fulali's house), Juku Saha, S/o Fulali Saha,
Bochu Saha, S/o Fulali Saha, Montu Saha S/o Fulali Saha &
Pintu Saha, S/o Mithu Saha these all accused came in front
of me at about 3:45 PM they drag me out from the →

home and started beating me mercilessly with kicks & ...
4) That all the male person of the accused came and bitted me
badly over my private parts of the body as a result internal
Bleeding occur and severe parts of my body is totally injured.

5) That all the male person accused also tore my clothes in front
of general public and tried to do unlawful activities. The
female accused also brought bamboo sticks, sharp instrument
and stated killing me badly over my head and back bone so
that all the accused tried to kill me.

6) That In the mean time the accused also took away my Golden
chain and finger ring when I became senseless seeing this
situation the neighbour people came, resqued me and took
me to Siliguri Sadar hospital where the doctor said that
its a Police case.

7) That I am a patient of several illness and inspite of that
knowingly all the accused beated me very badly and now
I am suffering from very painful moments.

8) That under his circumstances I pray before you with
folded hands to arrest the accused and to start a
investigation and also to register a case against the
accused.
