GREVIOUS HURT TO ME BY DANGEROUS WEAPON AND
THEFT OF GOLD CHAIN OF 15.00 GRAMS AND CASH OF
A SUM OF Rs. 9,500/- (RUPEES NINE THOUSAND FIVE
HUNDRED ONLY)**

I Bijay Mitra, Son of Late Kalipada Mitra, resident of Amtala Chayanpara, P.O. Gogomali, P.S. Bhaktinagar, Dist. Jalpaiguri, Pin: 734006 would like to state that I know one 1. Uttam Talukdar, Fathers name not known, resident of Amtalla Chayanpara, P.O. Ghogomali, P.S. Bhaktinagar, Dist. Jalpaiguri, 2. Debashish Singha Son of Not Known resident of haiderpara, P.O. Rabindra Sarani, P.S. Bhaktinagar, Dist. Jalpaiguri, and 3. Khokon Das, Son of Not Known resident of Uttar Chayanpara, P.O. Ghogomali, P.S. Bhaktinagar, Dist. Jalpaiguri, they are the land grabbers of the locality and they have been continuously threatening me over some land dispute for some period of time as they are trying to illegally grab the land. On 29.04.2021 when I went to Ektiasal More at a Medicine Shop at around 8: 50p.m. the aforementioned persons were present there and saw me and seeing me they approached towards me and started abusing me using filthy languages without any rhyme and reason and over the said quarrel said Uttam Talukdar called and instructed someone to come there alongwith other men and persons and as such around 20 (twenty) other men and persons reached there within 10 (ten) minutes armed with wooden rod and battam and all of them started beating me mercilessly with fist blows, battam and rods and they also snatched my gold chain weighing around 15.00 grams and cash of a sum of Rs. 9,500/- (Rupees Nine Thousand Five Hundred only) after assaulting me in such manner about 15 to 20 minutes they left away. The neighboring people thereafter took me to Siliguri District Hospital and I was admitted there. Due to the aforesaid assault I sustained severe injuries and also experienced severe pain on my ribs, chest and on the back side of my body and also experienced breathing problems. the Siliguri District Hospital I was treated there and although they were not willing to discharge me I considering the pandemic situation owing to the Nobel Coronavirus asked them to discharge me and presently I am advised bed rest and is under medication.as I was admitted in the hospital the aforementioned miscreants came to my house at night and threatened my wife that if I will try to lodge complaint against them then they will kill me and my entire family.

Under the above circumstances I hereby lodge this complaint against 1. Uttam Talukdar, Fathers name not known, resident of Amtalla Chayanpara, P.O. Ghogomali, P.S. Bhaktinagar, Dist. Jalpaiguri, 2. Debashish Singha Son of Not Known resident of haiderpara, P.O. Rabindra Sarani, P.S. Bhaktinagar, Dist. Jalpaiguri, and 3.Khokon Das, Son of Not Known resident of Uttar Chayanpara, P.O. Ghogomali, P.S. Bhaktinagar, Dist. Jalpaiguri, and other 20 (twenty) unknown miscreants for Voluntarily causing grievous hurt by dangerous weapon and means and snatching away my gold chain and cash of a sum of Rs. 9,500/- (Rupees Nine Thousand Five Hundred only) and further threatening my family members and would humbly request you to investigate the matter so that the wrong doer can be punished as per law.
