
Sir, with due respect it is requested that I No-03005233 CT/DVR Ranjit Singh of 21 Bn BSR attached with STC BSR Baikunthpur. As a driver of Ambulance Reg. No WB-66A-3700, on 30-4-21 at about 1415 hrs when I was carrying a patient namely Mrs. Snehada, -3443 from CH Kadamtale (BSR Hospital) to 03 BSM Diagnostic service in route on Asian Highway-02, near Agarwal Bhawan. Suddenly an Auto Rickshaw No. WB-73A-8096 while overtaking on other Auto rickshaw coming my lane Ambulance and hitted by at right side. My Ambulance, I applied emergency break but could not prevent the collision as a result of collision right side of Ambulance got damaged completely and above mention patient viz Snehada-3443 also got injured, the extent of her injury will be fully ascertained. After X-ray report the reportedly injury her left shoulder. The Auto rickshaw which collided with Ambulance also got damaged and three personnel sitting in it including DVR also got injured. I along with the passes by pulled them out of Auto rickshaw and handed them over to on other passing by Auto rickshaw which admitted in the name of H. Name it is patient do mention that...

rickshaw Driver MIZ Jaydev Thakur (allegedly) aged

taking on other vehicle and while overtaking
his vehicle come in front of my Ambulance

prossion ground helled the injured and got them
admitted in NBMCH with the help of fallen
by as mentioned above.
