Dear Sir/Ma'am,

I **SMT. MOUSUMI ROY**, W/o Sri Sanjay Paul, Daughter of Umesh Roy, Resident of Bagdogara, Hospital More, P.S. Bagdogara, District- Darjeeling, would like to lodge a written complaint against the above named persons as follows:

- 1) That Sri Sanjay Paul in the year 2014 to 2015 made sexual intercourse with me on several occasions when I was **minor** on the pretext that he loves me and will marry me.
- 2) That in the year 2015 I refused to terminate the baby in my womb which he in the past done on so many times against my will and wish.
- 3) That on 27.09.2015 he allegedly married me in a local temple and thereafter he insisted me to terminate the baby as it would not be possible to become parent at that stage to which I agreed.
- 4) That after the marriage I started living with my husband at his residence at Siliguri Bazar, Ashoke Nagar, Ward No.32, Dist.-as husband and wife and the family of my husband consists of my father-in-law namely **Sri Sankar Paul**, my mother-in-law namely **Smt Khona Paul**, Sister-in-law namely **Smt Sumana Paul** and Brother-in-law namely **Sandip Paul**.
- 5) That it is relevant to mention here that my husband is A.S.I. posted in Khoribari Police Station.
- 6) That out of the said wedlock one daughter was born on 22.02.2018 namely **Miss Sampurna Paul**.
- 7) That since the very inception of my marriage my husband and my in-laws misbehaved with me for not bringing enough expensive articles like LCD
