

COMPLAINT AGAINST ILLEGAL AND UNAUTHORISED CONSTRUCTION

Sir,

1. This is to inform you that a new construction was observed adjacent to boundary wall of Air Force Station Bagdogra in village Abhiram Jote in front of Base Ops and SRE Radar. On inquiry, it was learnt that the construction work has been undertaken by Sh Dheeraj Ghosh (M-8016197680) thereby violating the restrictions imposed therein. On 08 Apr 21, Rep of this station visited the work site from outside and met Sh Praveen Gupta Site Engg and informed to stop the construction work immediately and report to Station Security Section along with documents. Till date no one reported to this office and neither stopped the construction work.
2. Vide Govt of India S.R.O 4 dated 13 Jan 2010 published vide Gazette of India dated 23 Jan 2010 read with Works of Defence Act 1903 (7 of 1903), the central Govt has imposed following restrictions on construction adjacent to Air Force Stations.
 - (a) No building or structure shall be constructed, created or erected within limits of 100 meters from the crest of the outer parapet of Indian Air Force Stations and installations.
 - (b) No building or structure shall be constructed, created or erected and no tree shall be planted on any land within limits of 900 meters from the crest of the outer parapet of Indian Air Force Stations and installations except that the limit of 100 meters will extend to 900 meters from and in line with the boundary of the Bomb Dumps at Indian Air Force Stations and installations.
3. That the public notice In respect of the above mentioned Govt of India was promulgated by District and Land Reforms Officer and DM Darjeeling vide Memo No 1594/7/GEN/DEF/DELLRO-DJ/10 dated 12 October 2010.
4. That all such buildings, trees and plantations infringing the restrictions notified vide the abovementioned Govt of India S.R.O and Public Notice are unauthorized and illegal and therefore liable to be removed and / or pushed beyond the limits of the restrictions in the interest of National Security.
