Sir,

I, Smt. Somalika Ghatak, w/o Sri Subha Maity, d/o Sri Samarendra Nath Ghatak, and presently residing at my parents house at Gossainpur, P.O. & P.S.:- Bagdogra, Dist.:- Darjeeling, W.B. categorically complain before you, having no other option, as in the following:-

My marriage was solemnised and registered on 17/10/2017, with Sri Subha Maity son of Sri Shankar Maity of P.O. & Village:- Subdhi, P.S.:- Nandigram, Dist. Purba Medinipur, West Bengal, in the office of the Marriage Officer at Nandigram. Subsequently, a social marriage ceremony was performed on 22/11/2017 at my in-laws place as above said.

Be it noted that our relation got developed through mobile conversation and message and subsequently on 15.09.2017, my husband came at Gossainpur and took me to Heriapur, P.S.:- Nandipur, Dist. Purba Medinipur, W.B. to his aunt's ("masi") house but my parents were not informed before our departure. After staying for some days in my aunt's house, I was then taken to Nandigram where on the said date my marriage was solemnized and registered.

At the time of my marriage my husband was employed in a private company at Punjab and also he used to earn from agriculture produce and fishery farming. But after marriage my husband and members of in-laws family used to inflict mercilessly torture me, physically and mentally. I was not given food properly and at times they used to keep me starved too. Due to which I became very sick and I was given medical treatment only after my father sent money to my husband.

In the meantime, my father's health got highly deteriorated and I came back at my parental home, with my own uncle, on 01/06/2020. During my stay I was also given medical treatment and after feeling better I was taken back on 12/10/2020, by my husband to his home.

Day by day my husband and members of in-laws house kept on pressurizing me to bring money from my father. They demanded about 11 lakh for my husband's employment and also demanded money for purchasing motor bike and also for construction of their house. They also used to demand money for any ceremonies at their home.

Out of the sense of propriety I continued to live with my husband in my in-laws house with a hope for a good conjugal life. But gradually I noticed that as my father refused to meet their demands, my husband started to mentally torture me in different manners. Intentionally he used to show me a photo of one girl named Lipika (as was told by him) with whom he used to stay away for days together and he used to tell me that if she does not meet their demands, then will have no alternative but to give divorce and then he will marry any woman of his

choice. My in-laws and others also supported his mischievous and illegal acts to meet their demands. He also often used to threaten me with dire consequences and threat to my life.

Lastly, having no alternative and to save my life, on 21/03/2021 my mother, my own aunties (Pisi and Kaki) brought me back at my paternal home as I was unable to bear their torture.

Please note further that my marriage certificate and my other civil documents have been forcibly withheld by my husband and in-laws.

On 21/03/2021 at the time of my departure from my in-laws, my mother-in-law forcibly took away my gold Chain and 3 sets of gold ear ring which were given to me by my parents.

It is therefore prayed that your honour would be kind to register strong case against the culprits named hereinbelow as I am/was under extreme fear to lodge complain at the Police Station of in-laws locality and oblige.
