With due regard and humble submission Smt. Nitu Ray W/O Sri Suraj Shah and D/O Sri Niranjan Ray, Resident of Rajendra Nagar, Ward No-1, P.S- Pradhan Nagar, Siliguri, Dist- Darjeeling do hereby submit the following for your kind information and necessary Legal action :-

1. That I got married with Suraj Shah Son of Sri Shiv Shankar Shah, resident of Bagdogra Station More, P.O & P.S- Bagdogra, Dist- Darjeeling on 09-03-2018 according to Hindu rites and customs and was solemnized at Rajendra Nagar, Ward No-1, P.O & P.S- Pradhan Nagar, Siliguri, Dist-Darjeeling at my father's house and Smt. Lakhi Roy of Rajendra Nagar, Siliguri and her daughter Juli Roy of Bagdogra were the negotiator of my said Marriage.
2. That my Parents gave all households Goods/ things/articles which as per the demand of my in laws above named and my father/ mother also gave Rs.1,50,000/- in Cash, Golden Ring, Golden Chain, utensils, furniture as per their demands & as they will keep me in a proper way and after marriage I was taken to in-laws house at Bagdogra Station More, P.O & P.S- Bagdogra, Dist- Darjeeling to lead Conjugal life.
3. That after a Week my husband started demanding Android Mobile Phone from me and created pressure upon me to demand from my mother and my mother was compel to provide Mobile as demanded by my husband.
4. That again after one month of marriage my husband and in-laws above named started creating pressure upon me to bring money for the Business purpose and they all started torturing me mentally & Physically and my mother was again compelled to give Rs.50,000/- to my husband as demanded for his Business purpose.
5. That all the above named persons use to insult me in a very abusing language as my parents did not fulfill their demand of dowry, and I tolerated as one day all will be normal but all the in-laws use to torture me physically and mentally as their demands were not fulfilled and they did not provide me sufficient food to eat for their ill motive.
6. That the torture/cruelty upon me with a hope that they would realize their guilt but day by day the said currently upon me increased and forced/ torture me to bring money from my parents' house and when I refused then my husband and my mother in-laws & sister in- Law use to beat Assault me Physically and torture me mentally and did not allow me to talk with my mother.
7. That any how I use to tolerated the mental agony/ pain given by my husband & in laws, as one day everything will be normal & all right but all in vain.
8. That the illegal act and activities upon me by the in-laws and my husband became more severe and painful, I tolerated with a hope that they would realize their guilt and I tolerated as I was pregnant and my in-law & Sister-in-laws tried to abort my pregnancy and they did not allow me to eat sufficient food and took work from me like a servant and I use to Tolerate their illegal act and activities & mental torture with a hope that after birth of child everything will be normal and they always threaten me to leave the house or commit Suicide and they on several times made a conspiracy to kill me but I was saved with the grace of God.
9. That my in-laws did not allow me to talk with the neighbors or relative and my Parents and did not take me to Doctor and when I became serious then my husband and In-laws forced/ Compel me go to my parental house for treatment & delivery purpose otherwise they would terminate the Pregnancy and I was send to Siliguri at my parental house in ill condition.
10. That after the birth of a female child on 23-07-2019 & my Parents informed about the same but my husband nor the in-laws came to see me or the child till date nor came to know the whereabouts nor try to contact me and they always avoided me & the Child for their ill motive.
11. That my husband in the month of March came to my house and I was very happy that he would take me & the minor daughter back with him but after some time I came to know that he had come for Money for his requirements and not for me & the child and went away by threatening & abusing me in filthy language and my mother as my mother refused him to provide money.
12. That today I came to know that my husband with the help of my in-laws above named married another Girl and I along with my mother rushed to Bagdogra to know the facts and when I collected some of my known people and the mediator who arranged my marriage then seeing us my husband along with the said Girl ran away from the house.
13. That the above named person are very greedy and cunning and for money they can do any thing and they have smashed my life for their illegal desire and if they are not stopped then they will again spoil the life of another girl for their ill motive.

14. That my husband has married another Girl for money /dowry and have ruined my life for his illegal desire of do with the help of above named person unlawfully and in a illegal manner .

Under the above facts and circumstances you are requested to please do the needful to t necessary steps /action against my husband and all in-laws above named who have ruined my life and tortured physically and mentally and always behave in a cruel manner and for their illegal demand of dowry, and further reques punish them for their ill act , for which I shall be highly oblige.


