In producing herewith 06 (Six) accused persons namely 1) Ashok Majumder (45) s/o Lt Ashim Majumder, of Jyotshana Bakary, Hakimpara, W/No.15, PS Siliguri, Dist. Darjeeling (2) Swagata Saha (37) s/o Gosai Das Saha of Purba Vivekanandapally, Near Boro Office, Pushpalay, W/No. 38, PS-Bhakti Nagar, Dist. Jalpaiguri (3) Soumik Guha (51) S/o Lt. Rabindra Guha Of Lower Bhanunagar, W/No.43, Ps- Bhaktinagar, Dist- Jalpaiguri (4) Biswajit Das (39) S/O Lt Sukhendra Das of Bharat Nagar, W/No. 24, PO- Rabindra nagar, PS- Siliguri, Dist- Darjeeling (5) Timir Baran Saha (30) S/O Ratan Saha of Seth Srilal Market, City Tailar, W/No. 11, PS- Siliguri, Dist- Darjeeling (6) Ramesh Prasad (46) S/O Lt. I, SI Ashim Kr Das of Panitanki Town Out Post, PS- Siliguri, SPC do hereby lodge a written complaint against the above noted accused persons to the effect that on 25.04.2021 at about 12:05 hrs. while performing Patrolling duty at Hong Kong market area and found the above noted arrested persons were moving here and there without using face mask. On being asked they disclosed their name as 1) Ashok Majumder (45) s/o Lt Ashim Majumder, of Jyotshana Bakary, Hakimpara, W/No.15, PS Siliguri, Dist. Darjeeling (2) Swagata Saha (37) s/o Gosai Das Saha of Purba Vivekanandapally, Near Boro Office, Pushpalay, W/No. 38, PS-Bhakti Nagar, Dist. Jalpaiguri (3) Soumik Guha (51) S/o Lt. Rabindra Guha Of Lower Bhanunagar, W/No.43, Ps- Bhaktinagar, Dist- Jalpaiguri (4) Biswajit Das (39) S/O Lt Sukhendra Das of Bharat Nagar, W/No. 24, PO- Rabindra nagar, PS- Siliguri, Dist- Darjeeling (5) Timir Baran Saha (30) S/O Ratan Saha of Seth Srilal Market, City Tailar, W/No. 11, PS- Siliguri, Dist- Darjeeling (6) Ramesh Prasad (46) S/O Lt. Rajendra Prasad of Anandamayee Kalibari road, Haiderpara, W/No. 40, PS- Bhaktinagar, Dist- Jalpaiguri.

On interrogation, it could be learnt that they had no any reason to move here and there without using facial mask during Pandemic disaster situation. Over that some of the local peoples were also annoyed with the accused persons by such an act. Finding no other alternative, I arrested them U/S 41 Cr. P. C as there was no scope to give notice under 41 (A) Cr. P. C. On being asked the above noted persons stated that they were well aware of the Pandemic disaster situation and they were moving without facial mask & valid reason. They negligently and malignantly move to spread infection of any decease dangerous to life during unlock period.

Hence, they violated the order of the Govt. of West Bengal duly promulgated in order No 79-CS/2020 dated- 12/04/2020 and Govt of West Bengal vide notification no. 347-I.S.S/2M-24/2020 dated-03/06/2020 and Govt of West Bengal order no. 715-Home (Cons) / RIM (Cons)-92/2021 dated-17/04/2021 and Chief Secretary, Govt. of West Bengal memo no. 486-CS/2021 dated-24/04/2021. The above noted person has intentionally refused to comply with the Govt. order duly promulgated in view of break-out of pandemic COVID-19 throughout the State. Accordingly, I arrested the above noted accused persons U/S 41 Cr. P. C.

Under the above facts and circumstances I pray that a specific case may kindly be initiated against 1) Ashok Majumder s/o Lt Ashim Majumder, (2) Swagata Saha s/o Gosai Das Saha (3) Soumik Guha S/o Lt. Rabindra Guha Of Lower Bhanunagar, (4) Biswajit Das S/O Lt Sukhendra Das (5) Timir Baran Saha S/O Ratan Saha (6) Ramesh Prasad S/O Lt. Rajendra Prasad and arrange for its investigation.
