I, SI Ashim Kr Das of Panitanki Town Out Post, PS- Siliguri, SPC would like to lodge a written complaint against the above noted accused persons to the effect that on 25.04.2021 at about 13:15 hrs. while performing Patrolling duty at Hong Kong Market area, Siliguri where I saw the above noted persons moving here and there without using facial mask at that area. On being asked they disclosed their name as (1) Suraj Gurung (25) S/O Jit Bahadur Gurung of Sishudangi, Near Hanuman Mandir, PS- Matigara, Dist-Darjeeling (2) Debraj Banerjee (54) S/O Lt Moni Mohan Banerjee of Hakimpara, Sharat Bose road, W/No. 16, PS- Siliguri, Dist- Darjeeling (3) Gopal Debnath (46) S/O Lt Anil Debnath of Panjabipara shib mandir, W/No. 13, PS- Siliguri Dist- Darjeeling (4) Subrata Barman (22) S/O Lt Dhananjay Barman C/O Narayan Das of Bidhyachakra colony, W/No. 44, PS- Bhaktinagar, Dist-Jalpaiguri (5) Gourab Chanda (32) S/O Goutam Chanda of Pakurtala more, Near SBI Bank, Green Pix, W/No.15 PS-Siliguri, Dist- Darjeeling (6) Rintu Saha (29) S/O Manotosh Saha of Vidhyachakra colony, W/No. 44, PS- Bhaktinagar, Dist- Jalpaiguri.

On interrogation, it could be learnt that they had no any reason to move here and there without using facial mask during Pandemic disaster situation. Over that some of the local peoples were also annoyed with the accused persons by such an act. Finding no other alternative, I arrested them U/S 41 Cr. P. C as there was no scope to give notice under 41 (A) Cr. P. C. On being asked the above noted persons stated that they were well aware of the Pandemic disaster situation and they were moving without facial mask & valid reason. They negligently and malignantly move to spread infection of any decease dangerous to life during unlock period.

Hence, they violated the order of the Govt. of West Bengal duly promulgated in order No 79-CS/2020 dated-12/04/2020 and Govt of West Bengal vide notification no. 347-I.S.S/2M-24/2020 dated-03/06/2020 and Govt of West Bengal order no. 715-Home (Cons) / RIM (Cons)-92/2021 dated-17/04/2021 and Chief Secretary, refused to comply with the Govt. order duly promulgated in view of break-out of pandemic COVID-19 throughout the State. Accordingly, I arrested the above noted accused persons U/S 41 Cr. P. C.

Under the above facts and circumstances I pray that a specific case may kindly be initiated against (1) Suraj Gurung S/O Jit Bahadur Gurung (2) Debraj Banerjee S/O Lt Monimohan Banerjee (3) Gopal Debnath S/O Lt Anil Debnath (4) Subrata Barman S/O Lt Dhananjay Barman (5) Gourab Chanda S/O Goutam Chanda (6) Rintu Saha S/O Manotosh Saha and arrange for its investigation.
