In producing herewith three (03) arrested accused persons who disclosed their name & identity as (1) Sambhaji Baloso Kashid [28 yrs] S/O- Bhalaso Kashid of Tikiapara near NTS More, PS- Siliguri, Dist- Darjeeling, (2) Riki Talukdar [19 yrs] S/O- Sahadeb Talukdar of Shantinagar Amtala, PS- Bhaktinagar, Dist- Jalpaiguri & (3) Sumit Uddhav Paswan [21 yrs] S/O- Uddhav Paswan of New Cinema Hall Road near NTS More, PS- Siliguri, Dist- Darjeeling. I, SI Anup Kumar Singha of Siliguri PS/ SPC do hereby lodge this complaint to the effect that, on 27.04.2021 at 15.50 hrs during my mobile van duty, myself along with my accompanied force had been to Dabgram area, Siliguri, found the above noted persons were moving there without wearing masks on their face and without maintaining social distancing and also without any proper reason.


On being asked, the above noted persons stated before me that, they were well aware of the present pandemic situation and they supposed to remain in home and not to come out without wearing masks on their face.

Hence, they violated the order for combating the spread of COVID-19 as per order of Govt. of West Bengal vide order no-79-CS/2020 dated 12.04.2020, notification no- 347-I.S.S/2M-24/2020 dated 03.06.2020 and Memo no- 486-CS/2021 dated 24.04.2021 in view of break-out of pandemic COVID-19 throughout the country as well as State. Accordingly, I arrested them u/s- 41 Cr.P.C in c/w the case.

Now, I request you for starting a case u/s- 188/269/270 IPC R/W Sec. 51(b) Disaster Management Act, 2005 against the above noted arrested accused persons and arranged proper investigation of the case.
