I Champa Roy w/o Goutam Roy resident of Purba Chayanpara, Post: Ghogomali, P.S. Ashaktinagar, Dist Jalpaiguri, I here by lodge a Complaint for the accident happened on 15 March 2021 at night 11:30 pm. My husband Goutam Roy and his friend Subrata Das S/o Sudam Chandra Das of Baghadanga, Gangnapur, Nadia Ranaghat-II, was travelling by bike no WB52AV0792 from Salugara to home. On the way near payel cinema hall Pranamy mandir Crossing Sevoke Road. When an Unknown Vehicle from Opposite direction suddenly hit them and ran away. This caused serious injury to both my husband and his friend Subrata Das. And were shifted to Anandlok hospital by the local people. They were later seriously injured. So, My husband was been taken to Patna and here lost his right leg. And his friend has gone through major operation in rayhali in North 24 parganas. It has been late to lodge a F.I.R because My husband was having treatment out station at Patna. The accident occur due to rough and negligent driving of the said unknown vehicle driver. So, I therefore request you to take action as per law against the unknown vehicle driver.
