In producing herewith four (04) arrested accused persons who disclosed their name & identity as (1) Nayan Kabiraj [32 yrs] S/O- Lt. Anil Ch. Kabiraj, (2) Smt. Tultuli Kabiraj @ Tina [29 yrs] W/O- Nayan Kabiraj both of Prankrishna Colony, Ward no- 28, PS- Siliguri, Dist- Darjeeling, (3) Md. Fulbabu [30 yrs] S/O- Md. Lalu & (4) Md. Chand [32] S/O- Md. Lalu both of Tikiapara Majdur Colony, Ward No- 28, PS- Siliguri, Dist- Darjeeling. I SI Malay Kumar Roy of Siliguri PS/ SPC do hereby lodge this complaint to the effect that, on 02.05.2021 at 13.25 hrs during my mobile van duty, myself along with my accompanied force had been to Prankrishna Colony, Siliguri, found the above noted persons were gathered there without wearing mask on their face, without maintaining social distancing and without any proper reason.

On being asked, the above noted persons stated before me that, they were well aware of the present pandemic situation and they supposed to remain in home and not to come out without wearing mask on their face.

Hence, they violated the order for combating the spread of COVID-19 as per order of Govt. of West Bengal vide order no-79-CS/2020 dated 12.04.2020, notification no- 347-I.S.S/2M-24/2020 dated 03.06.2020 and Memo no- 486-CS/2021 dated 24.04.2021 in view of break-out of pandemic COVID-19 throughout the country as well as State. Accordingly, I arrested them u/s- 41 Cr.P.C in c/w the case.

Now, I request you for starting a case u/s- 188/269/270 IPC R/W Sec. 51(b) Disaster Management Act, 2005 against the above noted arrested accused persons and arranged proper investigation of the case.
